The meeting was called to order at 6:30pm by Chairman Andy Bushman, with Trustees James McCaskey and Nathaniel McDonald and Fiscal Officer Todd Ray present. Mr. Bushman led the Pledge of Allegiance.

The Trustees signed warrants 20317 through 20347 dated 8/13/24, totaling \$446,069.78; and the 7/29/24 bi-weekly payroll EFT vouchers 302 through 309 totaling \$11,241.06. Between meetings the Trustees signed warrants 20291 through 20316 totaling \$22,131.53.

Mr. McCaskey moved to approve the minutes of the Trustees Regular meeting Tuesday July 23 as presented. Mr. McDonald seconded. Motion carried with a unanimous vote. The Trustees initialed a correction to the July 9 meeting minutes.

Mr. Bushman asked for public comment. Several residents offered praise and gratitude for the coordinated effort of the Munson Road Department crew and Munson Fire Department staff for the excellent emergency response to dangerous conditions scattered all over the township in the wake of the violent thunderstorm that ripped through the area on August 8. Downed trees and electrical wires blocked roadways and created numerous hazardous situations, but the response was fast and professional. Roadways were re-opened and no injuries resulted. Additional appreciation was noted for the electrical linesmen brought in from around the country to join local First Energy teams to rebuild and restore power around the community.

FIRE DEPARTMENT

Fire Department Business Manager JP Szczyglowski reported that Munson Fire Department was awarded the \$100,000 grant for the purchase of two new LifePac cardiac monitors. Munson will pay a 5% match to a \$95,000 grant contribution. Munson Fire will order two of the advanced LifePac 35 units at a cost of \$125,603, and will pay the \$26,391.00 balance.

Mr. Szczyglowski provided some details regarding the numerous storm-related emergency calls involving downed "hot" power lines, a natural gas leak, and complicated priority call protocols. He noted that area hospitals and the fire station were operating on back-up generators for about 24 hours until power was restored.

ROAD DEPARTMENT

New Trucks

Road Superintendent Kirk Walker reported that the new trucks were about a week out from delivery, with the first one expected to arrive in a few days.

Storm damage

Mr. Walker also reported that most Township roads were re-opened by the end of the next day following the storm, but pointed out that ongoing clean-up of downed trees in the right of way on township roads is hampered by wires tangled among the trees and branches. The crew is not permitted to cut and clear trees with unsecured wires due to the risk.

TOWNSHIP BUSINESS

Baseball Field maintenance

Road Superintendent Kirk Walker stated that he had requested a quote from Innovative Companies for ongoing dragging and treatment of five ballfield infields, including Zambory Field.

New Truck Invoices

Jim McCaskey moved to approve an additional \$13,225.00 encumbrance to Henderson Inc. for the equipment outfitting on the two new Road Department trucks. Nate McDonald seconded the motion. Motion carried with a unanimous vote. (The additional expense was identified by Fiscal Officer Todd Ray when reconciling the invoices for the two trucks, and had been omitted from an earlier encumbrance. After discussing the invoice with the vendor he determined that the additional amount was a legitimate expense.)

Jim McCaskey moved to approve an additional \$367.50 encumbrance to Innovative Companies LTD. for extra work performed on ballfields in preparation for Community Day. Nate McDonald seconded the motion. Motion carried with a unanimous vote.

Community Day Picnic

Mr. Bushman reported that attendance was down at this year's picnic due to rain, but still had about 400 attendees. The Trustees expressed their appreciation for the office staff and Road department crew members who provided excellent planning, preparation, and support to make the picnic a success again this year.

Storm Related Board Action

Andy Bushman moved to approve Resolution 2024-33, commending Geauga Family YMCA for the generous offer to all area residents to come to the YMCA to access hot-water showers, internet, and snacks while their homes were without power. The offer was extended to anyone, without regard for YMCA membership. Mr. McDonald seconded. Motion carried with a unanimous vote.

The Trustees also signed letters of appreciation to First Energy, and the Munson Fire Department and Road Department for their outstanding service to the community.

Jim McCaskey reported that a resident had requested a speed study for Mayfield Road between Bass Lake Road and Ravenna Road (Rt.44) with the hope that the speed might be reduced from the current 55 mph. The stretch of roadway has seen several accidents recently in the approach to the traffic signal at Bass Lake Rd. He explained that this road is under the jurisdiction of Ohio Department of Transportation. Mr. McCaskey moved to request O.D.O.T to complete a speed study for the described section of Mayfield Road. Nate McDonald seconded. Motion carried with a unanimous vote.

NOPEC Grant

Mr. Bushman noted that Munson has about \$20,000 available through NOPEC through the end of next year. He believes the weather web-camera the Trustees have been considering may qualify for the grant funding.

Workers Comp Grant

Mr. Bushman reported that he had worked with Office Manager Paula Friebertshauser and Road Superintendent Kirk Walker to complete and submit the application for a Workers Comp funded grant for a hydraulic lift for the Road Department.

FISCAL OFFICER

Resolution 2024-34: Fund Transfer

Mr. McDonald moved to approve Resolution 2024-34, a resolution to reallocate funds within the General Fund, the Fire Fund, and the Road and Bridge Fund. Jim McCaskey seconded. With a unanimous vote, the motion carried. (The Resolution, in its entirety, is included on a separate page of the minutes.)

Other Business

New addresses

Jim McCaskey discussed the current procedure for resident property owners to request a new address when building on an unimproved lot. The County Engineer's office notifies the Munson Board of Trustees liaison with the proposed new address and hopes to get a timely response back from the liaison approving the address so the driveway and building project can move forward. The Trustees reviewed the approval process and agreed that the liaison will share the proposed address information with the other Trustees and allow 24 hours for them to review the information, offer feedback, or allow the liaison to approve the address at his discretion.

Control Line Model Aircraft Flying

Resident Joseph Otto addressed the Board with a proposal to allow recreational control line model aircraft to be flown on township park properties, specifically baseball field infields. He explained that the battery powered electric propulsion model planes are tethered to a small cable and flown in a circle with a radius of 70 feet or less, and are quieter than combustion engine model planes. Mr. Otto indicated that the activity would be monitored by North Coast Control Liners, a model aircraft club, and would be conducted safely and responsibly in accordance with rules and guidance of a national governing body of model aircraft operations, the Academy of Model Aeronautics. He believes these model aircraft provide an opportunity to engage young people in the science of aeronautics while expanding and diversifying the use of
