The meeting was called to order at 6:30pm by Chairman Jim McCaskey with Trustees Andy Bushman and Irene McMullen and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Trustees signed warrants 14360-14384 dated 8/23/16 totaling \$124,476.09 and EFT Vouchers 739-748 for the 8/26/16 biweekly payroll totaling \$9,486.74. CEMETERY DEED

METZENBAUM CENTER/GEAUGA COUNTY BOARD OF DEVELOPMENTAL DISABILITIES

Don Rice representing the Geauga County Board of Developmental Disabilities and the Metzenbaum Center thanked the community for its support. There are no levies up for renewal this year. He was present to inform the community about the services provided. As a result of efforts to meet federal and state mandates, 80-90 clients are now working in the community, and fewer at the Metzenbaum Center. This has allowed them to open the center at no charge for use as a community center weekdays until 8pm. Several groups have already taken advantage of the opportunity for gatherings, and sport, dance, art and music activities, which are open to the public. FIRE REPORT/CHIEF MARK LYNN

Chief Lynn advised that the "Healing Wall", a traveling replica of the Vietnam Veterans Memorial, will pass through Munson Township to the Geauga County fairgrounds in Burton where it will be on display September 8-11. The fire station will have its Halloween open house on Monday, October 31. The flagpole will not look right at the north entrance and may interfere with gas lines at another location. Mr. Bushman gave him a contact to follow up. Mr. McCaskey asked if the department could reconfigure parking in the bay so that all of the trucks will go out the front over the concrete pad. The Chief said that the department is looking into it.

ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

Prospective road department employee Keith Kriynovich passed his driving and background checks and scheduled his physical. He will be required to get his temporary CDL.

Mr. Teichman recommended that he be hired for a September 6 starting date at a salary of \$17 per hour because he is a certified mechanic.

Andy Bushman moved and Irene McMullen seconded to hire Keith Kriynovich for a start date of September 6, 2016, at a starting salary of \$17 per hour, with the temporary CDL license to be required, with a unanimous vote. Motion carried.

Teichman advised two residents on Beechnut Road replaced their berms with topsoil. They will be contacted.

FARMLAND PRESERVATION MEETING

Mrs. McMullen attended the Ohio Department of Agriculture Farmland Preservation meeting in Columbus on August 18. The County Commissioners refused to sponsor an application from the McDonald family for the Hilltopper Farm in Munson Township. In several counties, the Soil and Water Conservation District is the sponsoring agency. A Township can also sponsor. Before following through with the application to become a sponsor for farmland preservation, McCaskey asked her to find out if the McDonalds were still interested, or if they had joined another federal program.

BUDGET HEARING

The Fiscal Officer and Trustees McCaskey and Bushman attended the Budget Hearing for the 2017 Budget at the county auditor's office on August 23rd. The budget was approved.
