The special meeting was called to order at 6:30pm by Chair Irene McMullen with Trustees Andy Bushman and Jim McCaskey and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Trustees signed warrants 12829-12880 dated December 30, 2014 totaling \$51,649.71, EFT vouchers 496-505 for the 12/19 bi-weekly payroll totaling \$10,987.68, 511-515 for the 12/31 monthly payroll totaling \$7,432.39, 1-11 for the 1/2/15 bi-weekly payroll totaling \$10,957.28, and Warrant 1196 dated 12/30/14 to transfer \$7,000 from the EMS lockbox to the primary account.

#### **MINUTES**

Andy Bushman moved and Jim McCaskey seconded to approve the minutes of December 9, 2014, as written, with a unanimous vote. Motion carried.

#### PUBLIC COMMENT

There was no public comment.

#### **DEPUTY CONTRACT**

Deputy Gary Gibbons introduced Deputy Evan Reinhart who will be the township's assigned deputy beginning January 1. Deputy Gibbons will brief him on Munson's areas of concerns. Deputy Reinhart gave the Trustees his contact information. One Trustee will be assigned as the liaison with the Sheriff's Department at the organizational meeting. Mrs. McMullen advised that any Trustee may call if the situation warrants it. Deputy Reinhart will attend the first meeting of every month.

#### FIRE DEPARTMENT/FIRE CHIEF MARK LYNN

Chief Lynn reported that the roof was insulated over the weekend. The fire department is painting the interior of the fire station. The new fire truck is expected to be completed the second or third week in February. The Chief will have pictures of the progress in the next few days. He inquired about purchasing equipment for the new truck. He was advised that the township budgeted \$50,000 for the expense. The funds will be placed on a blanket certificate and can be used to reimburse the fire department or to pay the vendors directly. Chief Lynn asked to use the proceeds from the sale of the old fire truck to purchase rescue tools. The light bars need to be replaced on the older trucks and the fire department is looking into options to save money. To expedite the sale of the old truck, the Chief suggested that the township sell it to the fire department for \$1.

#### **COUNTY HIGHWAY USE MANUAL**

A resolution to cooperate with the county engineer for work in the township road right-of-way was before the Board for consideration. Mr. McCaskey reviewed the county engineer's highway use manual and found a few areas of concern. The manual makes no provision for township regulations if they differ. For example, township zoning requires a 40 foot driveway entrance, while the county requires 30 feet. The provision was put in for snow removal and accessibility for emergency vehicles. The county also requires a bond for work in the right-of-way, which the township currently does not require of its residents. The county is in the process of revising its manual. The Trustees agreed to wait until the county has completed its revisions and the township's issues have been addressed.

#### FOWLERS MILL GUARDRAIL

Mr. Teichman advised that the description caused the confusion, and the linear footage for a guardrail on both sides of the road was the same. The quotes were \$13,312, which included mobilization, and \$16,000. Mr. McCaskey was concerned about going against the county engineer's recommendations and guidelines. Mrs. McMullen wanted the guardrail for the protection of the residents, especially the students driving to school. The design was based on people not exceeding the speed limit. She said that it was the purpose of local government to be able to look at each case on its own merits. The township has the authority to put up the guardrail if it chooses. She wanted to contact the Painters, who live on the other side of the bridge, for their opinion. Mr. Teichman read the notes aloud from the preliminary discussion between the county engineer and homeowners regarding the guardrail. Resident Bob Voss joined the meeting. Mrs. McMullen recapped the quotes and the township's position. Mr. Voss asked if the issue was liability or cost and suggested that the township check the slope rating to make sure that it was the required 3-1. The Board discussed the hump in the bridge. Mrs. McMullen will contact the engineer's office and the Painters. The guardrail will be placed on the agenda for further discussion at the January 13th meeting. Mr. McCaskey thanked everyone who was part of the decision-making process for their professionalism and candor.

#### POINT OF CONTACT FOR ENGINEER'S OFFICE

The point of contact for the engineer's office will be designated at the organizational meeting. Woodiebrook Road will be placed on the January 13 agenda.

#### MILLSTONE SNOW PLOW ISSUE

#### **RUBBISH DAY**

The Department on Aging would like to set their schedule for senior assistance for rubbish day. The township will continue to have rubbish day the last weekend in April and assist seniors the weekdays prior.

#### **NORTHCOAST AERATION**

The cost to continue monitoring of the township drip system with Northcoast Aeration is \$500 and will be encumbered in 2015.

#### VAN HANDICAP PARKING

Mr. McCaskey addressed the slope at the van accessible parking space at the entrance to the town hall. The township put in the additional parking space at the request of the election officials. The access can be moved to the other side if the van backs into the space. Mr. Teichman will change the markings. The township needs to determine how many handicap parking spaces are required. NERO PARK SPRUCE TREES

The spruce trees were not moved at Nero Park as the ground was too wet. Mr. Teichman suggested that the township save the \$500 expense and cut down one of the trees next year and donate it for Christmas.



# RESOLUTION OF CONVENIENCE & NECESSITY FOR THE IMPROVEMENT OF BEECHNUT LANE (TR 891), RIVER ROAD (TR 922), EPPING TRAIL (TR 923), WATERFOWL LANE (TR 926), AND STEVENS WAY (TR 1000) Munson Township, Geauga County, Ohio

WHEREAS, the Munson Township Board of Trustees has determined that the public convenience and welfare require the improvement of Beechnut Lane (TR 891), River Road (TR 922), Epping Trail (TR 923), Waterfowl Lane (TR 926), and Stevens Way (TR 1000) and to authorize the Geauga County Engineer to prepare engineering plans in accordance with Section 5573.01 of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED by a unanimous vote of a full board of the Munson Township Board of Trustees that the public convenience and welfare requires the improvement of Beechnut Lane (TR 891), River Road (TR 922), Epping Trail (TR 923), Waterfowl Lane (TR 926), and Stevens Way (TR 1000) in the Township of Munson, County of Geauga and State of Ohio by repairing the existing pavement and embankments, replacing culverts, cement stabilization, asphalt resurfacing and stabilizing the shoulders, as necessary.

**BE IT FURTHER RESOLVED** that the Geauga County Engineer is hereby directed to make such surveys, plans, profiles, cross sections, estimates and specifications as are required for the improvement and to transmit copies of the same to this board.

**BE IT FURTHER RESOLVED** that the costs and expenses of said improvement shall be apportioned as follows:

The right of way costs, if any, and the construction costs for the project shall be paid from local funding sources. The engineering will be provided by the Geauga County Engineer at no cost to the Township.

**BE IT FURTHER RESOLVED** that the Fiscal Officer of the Munson Township Board of Trustees is hereby instructed to transmit a certified copy of this resolution to the Geauga County Engineer.
