The meeting was called to order at 6:30pm by Chairman Andy Bushman with Trustees Jim McCaskey and Irene McMullen and Fiscal Officer Judy Toth present. Warrant 12951 dated 2/9/15 in the amount of \$340.11 was signed between meetings. The Trustees signed warrants 12927-12950 and 12952-12964 dated 2/10/15 totaling \$37,936.11, EFT vouchers 71-81 for the 2/13/15 bi-weekly payroll totaling \$11,882.32, and warrant 1199 dated 2/10/15 in the amount of \$4,621.54 to transfer EMS collections from the lockbox.

MINUTES

Jim McCaskey moved and Irene McMullen seconded to approve the minutes of the January 13, 2015 public hearing, as written, with a unanimous vote. Motion carried.

Jim McCaskey moved and Irene McMullen seconded to approve the minutes of the regular meetings January 13 and January 27, 2015, as written, with a unanimous vote. Motion carried. PUBLIC COMMENT

The Township places metal stakes at the curve on Woodiebrook Road to guide the snow plows. Resident John Mascaro of Beechnut Lane asked the Trustees to replace the metal stakes with plastic markers, or to move them farther off the road. He cited instances of damages to vehicles, one where the damage was extensive. The Trustees noted that the road pitch contributes to the problem of cars veering off the road. The county engineer is reviewing the situation. Superintendent Jim Teichman joined the meeting and advised that the plastic markers cost \$28 apiece and are subject to vandalism and theft.

FIRE DEPARTMENT/FIRE CHIEF MARK LYNN

Fire Chief Lynn reported that due to minor delays the new truck will not be ready until mid-March. The fire department is contacting prospective buyers for the old truck. Boak will be out next week to evaluate the insulation. Superintendent Teichman showed pictures of ice buildup on the exterior of the building. The fire contract is up at the end of March and the fire department is preparing a budget for contract discussions. Chief Lynn asked if the Trustees were considering a one-year or multiple-year contract.

DEPUTY REPORT

Sheriff's Deputy Evan Reinhart reviewed January citations, warnings and incidents and submitted his report. He discussed one minor burglary on Sherman Road, a natural gas leak at Circle K, and a high incidence of speeding on Wilson Mills Road.

ROAD REPORT/ROAD SUPERINTENDENT JIM TEICHMAN

Superintendent Teichman requested authorization to seek bids for materials and catch basins and quotes for rubbish day.

Jim McCaskey moved and Irene McMullen seconded to allow Jim Teichman, Road Superintendent, to obtain clean up quotes and spring bids for bid opening March 24, 2015 at 6:45pm, with a unanimous vote. Motion carried.

Teichman submitted quotes for flags for the cemeteries and parks.

He met with OTARMA loss control, and gave the Trustees a sample checklist, provided by OTARMA, which the road department will use to inspect trucks and equipment. Employees will also begin noting on their time sheets when signs are repaired and inspected. OTARMA provided a "hold harmless" form, which they recommended that the township include with contracts. The Trustees will review the form and forward it to the county prosecutor. Teichman brought in samples of reflective safety jackets to be purchased with OTARMA MORE safety grant funds. Road department employee Adam McKinney is certified to apply pesticides. Mark Stukbauer attended a core training today. If he passes the required test, he will be allowed to apply pesticides under Adam's supervision.

RESOLUTION 2015-07/INTENTION TO PROCEED WITH TOWNSHIP ZONING

Resolution 2015-07 was made by Jim McCaskey and seconded by Irene McMullen to prosecute the property owners at 11805 Julie Drive for failure to obtain a zoning permit pursuant to ORC Sections 519.03, 519.23 and 519.24, with a unanimous vote. Motion carried.
