The meeting was called to order at 6:30pm by Vice-Chairman Andy Bushman with Trustee Jim McCaskey and Fiscal Officer Judy Toth present. Trustee Irene McMullen was absent. Mr. Bushman led the Pledge of Allegiance. The Trustees signed warrants 14739-14758 dated 2/28/17 totaling \$67,770.55, EFT Vouchers 61-71 for the 2/24/17 biweekly payroll in the amount of \$11,542.78, EFT Vouchers 76-80 for the 2/28/17 monthly payroll in the amount of \$6,899.92, and warrant 1248 dated 3/31/17 in the amount of \$8,560.83 to transfer EMS collections from the lockbox. Warrant 1247 was voided.

MINITES

Jim McCaskey moved and Andy Bushman seconded to approve the February 14, 2017 minutes, as presented, with both Trustees voting yes on the roll call. Motion carried.

PUBLIC COMMENT

There was no public comment.

CONTRACT FOR ADDITIONAL PATROL

Deputy Brian Phan introduced himself and asked the Board for their expectations. He has 34 years' experience with Bainbridge Township and 18 years with the Sheriff's Department. Mr. Bushman asked him to watch for speed violations for school traffic on the cut-through roads, Fowlers Mill from Thwing to 322, Butternut, Rockhaven and Wye, and Bass Lake Road. Optimum times are 7:10-7:40am and 2:30-3:30pm. He noted that the flashers for Munson Elementary most likely will not be installed this school year.

FIRE DEPARTMENT/CHIEF MARK LYNN

Chief Lynn sent the Trustees an updated five-year plan with a stipulation on the squads. The run volume is up for this year. After several phone calls to no avail, Geico has closed the case for the damaged squad. He asked for authorization to cash the \$500 check, which will pay the cost for the repair parts. Mr. Bushman asked to review a copy of the check. The final cost for additional equipment as part of the SCBA grant will be approximately \$1,500. The fire department will have the final figures next week.

ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

Mr. Teichman requested \$80 to send two road department employees to an asphalt preservation seminar on March 23 in Akron.

Jim McCaskey moved and Andy Bushman seconded to authorize Jim Teichman to send two employees of his choice to an asphalt preservation seminar for a total of \$80, with both Trustees voting yes on the roll call. Motion carried.

RECYCLING AREA

Mr. McCaskey received a phone call from the neighbor to the north of the fire station asking the Township to erect a fence to block the unsightly recycling area. The condition is poor since Chardon and Hambden closed their facilities. The township has added additional boxes. Mr. McCaskey asked the county why they do not provide a site. The Trustees discussed reconfiguring the disposal boxes to reduce the impact on the neighbor, and asked the road superintendent to place one row of the cardboard collection boxes behind the other. Teichman was concerned that the back boxes would not be used and that cardboard would be left on the ground. Mr. McCaskey has the tools to install the chair rail in the community room and will rent them to the Township for \$1. The road department will perform the labor. Residents questioned the use of road department resources for general fund projects.

MEDICAL MARIJUANA

Mr. McCaskey advised that Chardon was approached regarding medical marijuana and was concerned that township zoning address this situation. The Munson Zoning Commission has not been able to set up a meeting with the county prosecutor.

RESOLUTION 2017-09/FUND TRANSFER

Resolution 2017-09 was made by Jim McCaskey and seconded by Andy Bushman to approve a within fund transfer in the General Fund in the Temporary Appropriation, with both Trustees voting yes on the roll call.
