The meeting was called to order at 6:30pm by Chair Irene McMullen, with Trustees Andy Bushman and James McCaskey and Fiscal Officer Todd Ray present. Ms. McMullen led the Pledge of Allegiance.

The Trustees signed warrants 19214 through 19226 dated 1/10/23, totaling \$23,742.69 and the 1/06/2023 bi-weekly payroll EFT vouchers 1 through 8, totaling \$10,399.48. Between meetings the Trustees signed warrants 19203 through 19213 totaling \$7,470.63.

Minutes

Jim McCaskey moved to approve the minutes of the Trustees Regular Meeting Tuesday, December 27, 2022 as presented. Andy Bushman seconded, and with a 3-0 vote the motion carried.

Public Comment

Resident Dawn Bastulli made a comment that she was impressed by the Fire Department presentation during the Special meeting earlier, and she felt that the importance of public safety justifies the levy request they propose, and the Trustees should not wait. Resident Glen Kinter echoed her comment, and feels a levy on the ballot in November is appropriate.

Resident Rich Ferlin shared an anecdote from a resident praising the Fire Department for a small but significant service response that was "above and beyond what's required and expected."

FIRE DEPARTMENT

Fire Chief Mike Vatty thanked the Trustees for the workshop and a forum to present their case for additional funding. He referred to additional statistical data in the report that was provided each Trustee during the special "workshop" meeting.

Chief Vatty reported that the staff has been working with the Road Department to get automatic external defibrillators for the maintenance building, and will coordinate so that the equipment is compatible with the units used by the Fire Department. They are also working to get "Stop the Bleed" first aid kits for the Road Department trucks, and hope to schedule CPR training for the crew.

ROAD DEPARTMENT

Road Superintendent Kirk Walker reported that Dave Jevnikar from Geauga Access TV is scheduled to do a site visit to the Town hall to finalize details of his proposal to install a webcamera on the front side of the Fire Station. Andy Bushman indicated that he has still not received a quote from the second vendor, Radio-active but will try to get it by the next meeting. Mr. Walker asked if the Trustees would have a Special workshop meeting with the Road Department to consider budget issues and capital investments in trucks and equipment. Jim McCaskey moved to have a Special meeting Tuesday, February 28 at 5:30pm to discuss Road Department budget matters. Andy Bushman seconded, and with a unanimous vote, the motion carried.

Andy Bushman noted that the Park Board has received applications from two candidates, and the Park Board will interview them at their next scheduled meeting.

Resolution 2023-02

Be it resolved by the Trustees of Munson Township, in a regular session on the 10th day of January, 2022, at the Munson Township office, with the following members present, James J. McCaskey, Andrew J. Bushman, and Irene McMullen, that

James McCaskey moved the adoption of the following resolution:

Whereas in 2003 Munson Fire Department implemented a billing program for emergency medical response services provided by the Department, and

Whereas since 2003 the EMS billing has generated collections that Munson Township receives into a dedicated lockbox account for banking purposes, and

Whereas funds from the lockbox account are certified and receipted into Special Revenue Fund 2281, to be appropriated for Fire and EMS purposes only, and

Whereas the current contract between Munson Fire Department and Munson Township, executed December 27, 2018 specifies the following:

Beginning January of each year the Township will begin to accrue, from the EMS fund carryover and new EMS funds, net of collection processing fees, received after the first of the new year, the total expenditure required to pay the current year's borrowed or leased payments for Fire Department Township-owned and titled apparatus and equipment vehicles. All EMS billing funds received by the Township in excess of the total expenditure required to pay the current year's borrowed or leased payments for Fire Department Township-owned and titled apparatus and equipment or for additional EMS funds which have been mutually agreed by the Parties are due and payable to the Fire Department within thirty days of receipt of such by the Township.

Therefore, be it resolved,

That the Trustees authorize the Fiscal Officer to reserve the necessary funds in the EMS Fund 2281 until sufficient funds accrue to meet all borrow and lease obligations, and to prepare corresponding purchase orders for Fire Department Township-owned apparatus and equipment lease payments from said Fund,.

Be it further resolved,

That the Trustees authorize the Fiscal Officer to make all borrow and lease payments per the calendar schedule, and to make the necessary payment of all EMS collections in excess of the total required for the year's borrowed or lease payments payable to Munson Fire Department.
