# RECORD OF PROCEEDINGS MUNSON TOWNSHIP TRUSTEES

The meeting was called to order at 6:30pm by Chairman Jim McCaskey with Trustees Andy Bushman and Irene McMullen and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Trustees signed warrants 13810-13819 dated 1/12/16 totaling \$8,461.02, EFT Vouchers 28-38 for the 1/15/16 bi-weekly payroll in the amount of \$11,538.20, and warrant 1221 dated 1/12/16 in the amount of \$2,593.22 to transfer EMS collections to the primary checking account.

<u>CEMETERY DEED</u> - The Trustees signed a deed to residents James E. and Ellen A. Heighway for Maple Hill III, Lot 331, Graves 5,6,7,8.

#### **MINUTES**

Irene McMullen moved and Andy Bushman seconded to approve the December 29, 2015 and January 5, 2016 minutes, with a unanimous vote. Motion carried.

#### SHERIFF CONTRACT REPORT

Deputy Savor will not be attending the meeting due to the weather conditions.

#### PARK BOARD EVENTS

Park Board member Jim O'Neill asked the Trustees to approve Park and Recreation event dates and budgets for 2016. The indoor flea market was already approved for March 19. Irene McMullen moved and Andy Bushman seconded to approve the events and budgets for 2016 with the exception of the Community Day Picnic, as follows: Indoor Flea Market, Saturday, March 19 - \$300; Easter Egg Hunt, Saturday, March 26 - \$500; Fishing Derby, Sunday, May 1 - \$300; Outdoor Flea Market, Saturday, September 10 - \$300; Fishing Derby, Saturday, September 17 - \$300; and Breakfast with Santa, Saturday, December 3 - \$800, with a unanimous vote. Motion carried.

#### **ROAD REPORT/SUPERINTENDENT JIM TEICHMAN**

Mr. Teichman asked the Board to approve the 2016 septic maintenance agreements, \$150 to DeGreen Construction Services, Inc. for the wastewater drip system annual inspection, to be conducted in the fall, and \$500 to North Coast Aeration Systems, Inc. for maintenance of the grinder pump and multi-flow tanks. He asked the Board to approve April 25, 26, and 27, (and April 28<sup>th</sup> if necessary) for Senior Assistance for Trash Day, and Trash Day for rubbish drop-off, Saturday, April 30 from 7am-3pm.

Irene McMullen moved and Andy Bushman seconded to schedule clean-up days for April 25, 26, 27, and 30<sup>th</sup>, with a unanimous vote. Motion carried.

He asked for authorization to prepare bid packages for road materials, virgin asphalt concrete, and catch basins and headwalls.

Irene McMullen moved and Jim McCaskey seconded to authorize the road superintendent to prepare bid packages for virgin asphalt concrete, road materials, and headwalls, with a unanimous vote. Motion carried. Mrs. Toth asked him to provide the bid opening date at the next meeting.

The Trustees were emailed copies of the mowing specifications prior to the meeting. Irene McMullen moved and Andy Bushman seconded to authorize the road superintendent to prepare spring mowing quotes, with a unanimous vote. Motion carried.

Irene McMullen moved and Andy Bushman seconded to contract with DeGreen for septic maintenance for the waste water drip system for 2016 not to exceed \$150, with a unanimous vote. Motion carried.

Irene McMullen moved and Andy Bushman seconded to contract with North Coast Aeration for 2016 for service of the multi-flo sewage treatment system in an amount not to exceed \$500, with a unanimous vote. Motion carried. The Chairman signed the service agreements.

#### FIRE REPORT/CHIEF MARK LYNN

Chief Lynn advised that everything was running smoothly and he had nothing new to report. BZA ALTERNATE

Michael Waclawski will be resigning his position as Board of Zoning Appeals alternate. Irene McMullen moved and Andy Bushman seconded to appoint Don Alexander to the Board of Zoning Appeals as an alternate for a two-year term ending December 31, 2017, with a unanimous vote. Motion carried.

### FISCAL OFFICER'S REPORT

Mrs. Toth advised that the Geauga County Township Association will begin a regular series of county seminars, with a 5-Year Budget Seminar February 20 at the Kent State University Branch in Burton from 9-11:30am. Mrs. Toth asked if the Board wished to schedule an Audit Committee meeting. Mr. Bushman suggested a meeting in April before the Trustees meeting, and asked her to contact Trevor Wilson for his availability.

The meeting was called to order at 7:22pm by Chairman Jim McCaskey. Present: Jim McCaskey, Irene McMullen, Andy Bushman and Judy Toth

The minutes for the bicentennial planning sessions will be taken by Clerical Assistant Julie Johnston.

Trustee Jim McCaskey started the meeting stating that it would be an open dialog. He mentioned that he had met with office staff the past two Wednesdays to get some Bicentennial ideas started. The most important decisions right now are where and when the Bicentennial event(s) will take place. Will the day be combined with the annual Community Day Picnic or be two separate events within the Township? Last year's Community Day Picnic was in competition with St. Mary's Festival. St. Mary's will hold their event July 29 – 31 this year.

Trustee Irene McMullen thought it would be nice to hold it at Fowlers Mill Road and Mayfield Road. The issue of safety came up with traffic on a main highway.

Mr. McCaskey mentioned that it would be nice to hold it at Town Hall. This way if the weather became inclement, event goers could go inside. Munson Township Park on Bass Lake Road would be perfect for additional parking and a bus could shuttle residents to Town Hall. Residents will be able to see the new building and fire station. The baseball fields are large enough to hold games, raffles etc. The possible date of July 16, 2016 was discussed.

Bob Voss, a Munson Township resident, mentioned that parking would be the biggest issue with the event and thought that it should be held at Alpine Valley Ski Resort since there is plenty of parking and residents can take a tour of the interurban, century homes on Fowlers Mill Road and stop at shops along the way with a shuttle pick up at Fowlers Milling Company. Horse drawn carriage rides on Fowlers Mill Road with a parade and several events in that area would tie it all together. Mr. Voss also mentioned that when there was the dedication, Fowlers Mill Road was closed and we could close it again if needed. Also suggested was having people come dressed with muskets and skins to make it feel more authentic.

Trustee Andy Bushman stated that he would like to make it two separate events with a few extra activities added for an old fashion flair; like a pie eating contest, 50 yard dash etc.

Mr. McCaskey and Zoning Inspector Tim Kearns will talk to Alpine Valley Ski Resort to see if they are interested in hosting the event.

Many people in the meeting were concerned. Most prefer the Community Day Picnic and Bicentennial combined into one event with all of the games, raffles and other activities. With the busy lifestyles that people lead these days, if there were two separate event dates, residents would choose one and not go to both.

The meeting concluded at 8:16pm.
