The meeting was called to order at 6:30pm by Chairman Jim McCaskey with Trustees Andy Bushman and Irene McMullen and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Trustees signed warrants 14674-14691 dated 1/24 and 1/31/16 totaling \$16,896.20, EFT Vouchers 17-27 for the 1/27/17 biweekly payroll totaling \$10,301.11; Vouchers 32-36 for the 1/31/17 monthly payroll totaling \$6,900.11, and warrant 1244 dated 1/24/17 in the amount of \$4,732.51 to transfer EMS collections from the lockbox. MINUTES

Jim McCaskey moved and Andy Bushman seconded to approve the January 10, 2017 minutes, as written, with a unanimous vote. Motion carried.

#### **PUBLIC COMMENT**

Donna Christley of 11458 Fowlers Mill Road asked the Board to set up a time to address the outstanding invoices for pipe installed on Fowlers Mill Road. With the proposed reduction in the road width, affected property owners wanted to know if they were responsible for work that may not have been required. The county has halted work on the plans until the Township decides when the project will be done. Mr. McCaskey asked the road superintendent to give him a list of the persons affected. Resident Bruce Oppenheim asked if the Board had made a decision on when the project would be done. Mr. McCaskey told him the Board would be working on the budget in February. Mrs. McMullen noted that restrictions on when certain trees may be removed may also affect the project schedule. Mr. Oppenheim asked the Township to cease any additional work until the plans are complete. Mr. McCaskey agreed with the exception of the two properties where the residents have asked for work to be done. Mrs. McMullen also wanted to make sure that emergency road work would not be exempted. Mr. Oppenheim said the county engineer was working on getting the speed limit reduced. McCaskey told him that the documents to request a speed study were mailed, and that the Board would sign them at the next meeting.

# CONTRACT FOR ADDITIONAL PATROL/DEPUTY STEVE SAVOR

Sheriff Deputy Steve Savor advised that a new deputy would be assigned to the Township. Mr. McCaskey asked him to brief the new person and thanked Deputy Savor for his professionalism and dedication.

## FIRE DEPARTMENT/CHIEF MARK LYNN

Chief Lynn reported that the fire department has been busy and is closing in on 100 calls for the month. He will have his 5-year plan done for the next meeting. He asked the Trustees to address replacing one squad. Its replacement has already been pushed back a couple of years. Mr. McCaskey asked about the incident at the corner of Bass Lake and 322. The Chief advised that the other driver was cited. Approximately \$450 damage was done to the squad. The cost will be for parts; the fire department can fix it in one day and will absorb the cost. The Trustees suggested pursuing restitution and asked the Chief to keep them posted.

#### ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

Mr. Teichman requested authorization to send road department members Adam McKinney and Doug Cross to OSHA training for construction trades/fall protection for the prevention of health and safety hazards in the workplace in Garfield Heights on March 14 & 15. There is no cost.

Jim McCaskey moved and Andy Bushman seconded to send Doug and Adam to the OSHA training in March for fall protection, with a unanimous vote. Motion carried.

Mrs. McMullen asked about a chain saw safety seminar, and Mr. Teichman told her he was in the process of setting one up. Other townships and local contractors will be invited to attend. Some of the residents present also expressed an interest. The Trustees will check their schedules to set up a workshop with the road department to take place at 2:30pm on a work day. They reviewed the letter which the Department on Aging will mail to Munson residents regarding assistance to seniors for rubbish day.

Jim McCaskey moved and Andy Bushman seconded to approve the letter informing residents about assistance to seniors on April 24, 25, 26, 2017, for rubbish day, with a unanimous vote. Motion carried.

Jim McCaskey moved and Andy Bushman seconded to approve up to \$650 for the purchase of geraniums and three flats of flowers for Memorial Day from Burton Floral and Garden, with a unanimous vote. Motion carried.

#### ROAD REPORT (continued)

Mr. Teichman had quotes from First Quality Sales and Alvord's Yard and Garden for a 14" chop saw at an approximate cost of \$950 at state purchasing price. The Board asked him to get a quote from Alvord's for the Husquevarna and asked if the quote for the Stihl was at state purchasing cost. Residents informed Mr. Teichman about pot holes on Fowlers Mill south of the bridge. He advised that the ones deep enough to hold the fill were done today.

#### RESOLUTION 2017-03/RETIREMENT OF BZA MEMBER RICHARD WRIGHT

Jim McCaskey moved and Andy Bushman seconded to accept Richard Wright's resignation, with regret, with a unanimous vote. Motion carried.

Resolution 2017-03 was made by Jim McCaskey and seconded by Andy Bushman to recognize Richard Wright for his 12 years of service on the Munson Township Board of Zoning Appeals, with a unanimous vote. #### RESOLUTION 2017-04/AUTHORIZATION TO PARTICIPATE IN THE LAEPP

Resolution 2017-04 was made by Andy Bushman and seconded by Jim McCaskey to authorize participation in the Ohio Department of Agriculture's Local Agricultural Easement Purchase Program [LAEPP], to support the Hilltopper Farm's LAEPP application, and to authorize the Township to accept and hold or co-hold agricultural easements on farmland accepted to the LAEPP program, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

#### **CULVERT INSTALLATION RULES AND REGULATIONS**

Resident Bernadine Okonek of River Road asked the Township to restore the fill dirt removed from her ditch and her neighbor's ditch in September 2015. She believed the ditches were dug too deep and has been working with Mr. Bushman and a local contractor to enclose her ditch with pipe. Mr. Teichman advised that she would need a permit from the township for a ditch enclosure and she agreed to follow up. Mrs. McMullen told her that the Township was in the process of preparing a policy for the disposal of excess soil. She was advised by the prosecutor's office that the Township should charge a reasonable amount. Mr. Bushman said the disposal of excess soil for ditch enclosures was addressed in his draft for culvert installation rules and regulations. Mrs. McMullen did not want to go against the prosecutor's advice.

Jim McCaskey moved and Andy Bushman seconded to give back the soil needed for the project to Bernadine Okonek and her neighbor. Roll call vote: Mr. Bushman, yes; Mr. McCaskey, yes; Mrs. McMullen, abstain. Motion carried. McCaskey reminded Mrs. Okonek to get the ditch enclosure permit and warned that if the enclosure did not work properly, the Township would have to remove it.

# MUNSON HOST GEAUGA COUNTY TOWNSHIP ASSOCIATION MEETING

Mrs. McMullen advised that it was Munson Township's turn to host the next Geauga Township Association meeting in April. The Township community room was available and she stopped at Guido's Restaurant for a menu. The owners are Munson residents. Mr. McCaskey suggested that Maple City TAPS also be considered as a caterer.

#### OHIO COOPERATIVE PURCHASING PROGRAM

Jim McCaskey moved and Andy Bushman seconded to approve the \$100 fee to continue the Township's participation in the Ohio Cooperative Purchasing Program, with a unanimous vote. Motion carried.

#### **CHARDON BASEBALL SIGNS**

The Trustees addressed a request from the Chardon Baseball League to place signs on the outfield fences as a fundraiser. Local businesses would purchase the signs. The signs would be uniform in size, and would be removed at the end of the baseball season. The Trustees discussed negotiating to receive a portion of the proceeds. Mrs. McMullen was concerned that if allowed for one group, the Township would have to extend this opportunity to all groups, and suggested that the prosecutor's office be consulted. She also wanted to know if the Township would have control over what signs were put up. Mr. McCaskey observed that these types of signs do not look good. He will be attending the Ohio Township Association Conference next week and will have an opportunity to discuss this with other townships. Resident Rich Ferlin asked about a sign policy.
