ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

Mr. Teichman requested \$80 to purchase two signs from All-ways Flasher for Allen Drive. A silt fence will be put up. The county does not have the final plan for Fowlers Mill Road, but Mr. Teichman will be able to proceed with drive pipe replacements. Mr. McCaskey thanked both the road department and fire department for their contributions to making the bicentennial a great event.

FIRE REPORT/CHIEF MARK LYNN

Chief Lynn reported that the hospital cancelled and will reschedule. They will attend a township meeting to formally present a new Life-Pak monitor to the Munson fire department. The fire station was open to the public during the bicentennial and provided slide shows and cotton candy.

HEALTH INSURANCE

The Township received an amended quote from Medical Mutual for the health insurance renewal reducing it to a 5.95 percent increase.

Andy Bushman moved and Irene McMullen seconded to approve the renewal of health care at a 5.95 percent increase, effective August 1, with a unanimous vote. Motion carried.

Chardon Township closed their recycling facility. This will put an additional burden on Munson and Claridon.
