Meeting

The meeting was called to order at 6:33pm by Chairman Irene McMullen, with Trustees Andy Bushman and Jim McCaskey and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. Warrants 12344-12355 dated 6/16, 6/17, and 6/20/14 totaling \$5,986.31 and EFT vouchers 240-245 for the 6/30/14 monthly payroll in the amount of \$7,542.69 were signed between meetings. Warrants 12356-12388 dated 6/24,6/25, and 6/30/14 totaling \$166,816.63 and warrant 1183 dated 6/24/14 in the amount of \$7,913.65 to transfer EMS collections from the lockbox to the primary account were signed. Correspondence was on the table. Mrs. McMullen signed the Statements of Values for the OTARMA insurance renewal effective 6/18/14.

MINUTES

Andy Bushman moved and Jim McCaskey seconded to approve the June 10, 2014 minutes as written, with a unanimous vote. Motion carried.

PUBLIC COMMENT - There was no public comment.

COMMENDATION JACOB NICHOLAS ROSBORIL

Mrs. McMullen read a commendation from the Munson Township Trustees recognizing Jacob Nicholas Rosboril for his participation on the Special Olympics softball team representing Team Ohio. Team Ohio advanced to the finals against the host state of New Jersey and won the Gold Medal. Jacob and his parents Joe and Yvonne Rosboril were present to accept the commendation, which is included on a separate page as part of the minutes.

FIRE DEPARTMENT

Fire Chief Mark Lynn gave his report. The fire department responded to roof problems at Notre Dame, winds tore the air conditioning unit from the structure causing water and roof damage, and to a structure fire on Fowlers Mill where the generator malfunctioned and caught fire.

New Fire Truck – Chief Lynn asked the Board for a decision on the fire truck. The Trustees received a lease financing proposal from Sutphen for three, five, or seven years financing. Mrs. McMullen reviewed the lease information. A resolution will be required to proceed. She asked Chief Lynn to contact Sutphen for the required paperwork and agreed to forward the information to the prosecutor's office as soon as she received it. The fire department hoped to have the new fire engine delivered by March or April of next year.

The second newest squad was taken to Countryside for a major repair to the engine at an estimated cost of \$5,000. That engine model has been experiencing problems and this should remedy the problem. Chief Lynn offered to postpone replacing the third cot to offset the expense. The squad is not projected to be replaced until 2019-2020. The fire department anticipates no major purchases for next year. The next major purchase will be to replace the demo squad in 2016-2017. The fire department may ask for an increase in the budget next year.

TOWN HALL PLAYGROUND/COMMUNITY DAY

Park Board member Art Hollis joined the meeting. The Trustees informed him that they received a landscape plan this evening before the meeting with a new location drawing for the town hall playground. Mr. Hollis reported that the Park Board will be in charge of the food tent for the Community Picnic. The fire department will cook the hotdogs. He questioned a request from the Boy Scouts to have a fundraiser at the picnic. The Trustees advised him that they have been doing this for the past several years.

APPOINTMENT TO GEAUGA COMMUNITY ACTION, INC.

Jim McCaskey moved and Irene McMullen seconded to appoint Andy Bushman to the Board of Community Action, Inc. as a representative of the Public Sector for a three-year term beginning October 1, 2013 to September 30, 2016, with a unanimous vote. Motion carried.

BASS LAKE COMMUNITY ROADS SPEED REDUCTION

Mrs. McMullen reported that Assistant Prosecuting Attorney Susan Wieland advised her that the township has enough documentation to pass the resolution to reduce the speed limit on the roads in Bass Lake Community to 25 miles per hour. All of the roads are in a platted subdivision and can be reduced by trustee resolution. Some signs have already been posted. Full posting would require approximately 76 signs. The board was not in agreement whether to post all required signs. Mr. McCaskey and Mr. Bushman will look at the roads prior to the next meeting, and the resolution will be placed on the next agenda.

RESOLUTION 2014-28/FUND TRANSFER

Andy Bushman moved and Jim McCaskey seconded to approve within fund transfers in the General and Road and Bridge Funds in the Permanent Appropriation, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

RESOLUTION 2014-29/ROAD 2.10 MILL 5-YEAR RENEWAL LEVY

Resolution 2014-29 was made by Andy Bushman and seconded by Jim McCaskey to place a 2.10 mill five-year renewal levy for the purpose of streets, roads and bridges on the November 4, 2014 ballot, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

RESOLUTION 2014-30/FIRE .65 MILL 5-YEAR RENEWAL LEVY

Resolution 2014-30 was made by Jim McCaskey and seconded by Andy Bushman to place a .65 mill five-year renewal levy for the purpose of fire operating and apparatus on the November 4, 2014 ballot, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

2015 BUDGET

The Trustees reviewed a list of capital projects for 2014 and 2015 and discussed the draft of the 2015 budget. Funding was not distributed for two major projects, the new fire truck and insulation for the fire station roof, and minimal funding was set aside for the Sherman Road improvement. Mr. McCaskey wanted to move the \$200,000 placed in the budget for the fire station driveway to the fire truck and fire station insulation line items. Mrs. Toth noted that a fire and a road levy are up for renewal, which will increase each of these funds by approximately \$100,000. She also informed the Board that she had to place \$336,000 in the General Fund for the 2015 fire contract. Mrs. Toth suggested including a letter with the 2015 budget regarding the three major unfunded projects to show need for the levies. The Board discussed financing for the new fire truck.

AUDIT COMMITTEE

Audit Committee member Trevor Wilson will be contacted and a date set for the next Audit Committee meeting. Mr. Bushman suggested that vendors be selected to be audited, and that the cost of the new building and the 2013 financial report be reviewed.

LIFE INSURANCE RENEWAL

Andy Bushman moved and Jim McCaskey seconded to renew the life insurance policy through Assurant Employee Benefits at the increased rate of \$338 effective July 1, 2014, with a unanimous vote. Motion carried.

HEALTH INSURANCE RENEWAL

The increase for health insurance renewal is 5.42%. Agent Sean Sprouse reviewed last year's Formfire applications and advised that it would be best to renew with the current policy. Andy Bushman moved and Jim McCaskey seconded to approve the health insurance renewal with Medical Mutual at \$8,778.95 effective August 1, 2014, with a unanimous vote. Motion carried.

ZONING COMMISSION OPENING

The Township received a resume from Carlye A. Burwell for the open position on the Zoning Commission. The Board will set up an interview for the next meeting.

OLD TV AND VCR

The Trustees addressed a request from the office staff to dispose of the old television and VCR. Andy Bushman moved and Jim McCaskey seconded to remove the television and VCR from the township inventory and to dispose of them, with a unanimous vote. Motion carried.

HEADSTONE REPAIR

The Board received an estimate of \$75 from Semerano Monuments to repair the Sherwood headstone at Fowlers Mill Cemetery. The family was contacted and had no objection to the proposal.

Andy Bushman moved and Jim McCaskey seconded to allow \$75 to Semerano Monuments to repair the cemetery stone damaged at Fowlers Mill Cemetery, with a unanimous vote. Motion carried.

PICTURE PROJECT

Mrs. McMullen asked Mr. Bushman to look over the historical pictures selected by Tim Kearns for display at the township hall. Mr. Bushman made selections. The Board discussed whether the pictures should be framed individually or in a collage and where the displays should be placed. Mr. Kearns will be asked to put together groupings. Mr. Bushman will look through his archives at home to see if he has pictures to add to the selection.

FOWLERS MILL BRIDGE PRECONSTRUCTION MEETING

Mrs. McMullen will attend the preconstruction meeting June 25 at 1pm for the county's Fowlers Mill Road bridge replacement project.


