The special meeting was called to order at 5:30pm by Chairman Andy Bushman with Trustees Jim McCaskey and Irene McMullen and Fiscal Officer Judy Toth present. The Trustees signed warrants 13214-13257 dated 6/4 and 6/9/15 totaling \$35,535.11, EFT vouchers 239-249 for the 6/5/15 biweekly payroll in the amount of \$11,202.40, and warrant 1207 dated 5/9/15 in the amount of \$8,880.22 to transfer EMS collections from the lockbox to the primary account.

#### **MINUTES**

Jim McCaskey moved and Irene McMullen seconded to approve the May 26, 2015 minutes, with a unanimous vote. Motion carried.

#### **CEMETERY DEEDS**

The Trustees signed deeds to Melvin and Linda Forman for Maple Hill III Cemetery, Lot 346, Grave 1 and Thomas L. and Iphigenia Planinc for Fowlers Mill II Cemetery, Lot 346, Grave 9.

#### **PUBLIC COMMENT**

Beechnut Lane is scheduled to be resurfaced this summer, which raises the road height. Several residents were present to object to their concrete driveway approaches being paved over with asphalt. Nine of the eleven driveways are concrete. The Trustees explained that grinding out the asphalt to maintain the same road height is not an option as it is a newer subdivision and there is not enough of a road base. The road department is sealing the cracks and doing deep depth repairs to prepare the road for paving. The Trustees asked the residents to come to the June 23<sup>rd</sup> meeting. The county engineer's office is researching options and has agreed to meet with the Trustees and residents. The Trustees will award the contract this evening in order to send the paperwork to the contractor. They advised that although they had no control over the schedule, they did not plan to sign the contract until June 23<sup>rd</sup> with the expectation that the work would not be done until late July or the beginning of August.

#### FIRE DEPARTMENT REPORT/CHIEF MARK LYNN

Chief Lynn reported that the damaged ladder truck is in the calculation phase. He expected to have an answer by the next meeting. NDCL has begun a major renovation of the elementary building and Sisters of Notre Dame living space and infirmary, to begin in the spring of 2016. Two of the buildings will be three stories bringing up the possibility that the Township may need to replace the ladder truck with another ladder truck. The Chief has asked to be allowed to see the preliminary drawings and to sit in on the construction meetings.

#### ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

The Township received a large amount of fill dirt from a new assisted living facility on Ravenna Road. The dirt will be used to fill in the old lake on the Klatka parcel next to Scenic River. The road department is saving all of the trees possible. Once the fill is completed, the space will lend itself to an extension of the walking trail at Scenic River, a picnic area, or a small ballfield, to be decided at a later date. Mr. McCaskey was interested in reviewing Mr. Teichman's preliminary sketch.

#### NEW PLAYGROUND

Mrs. McMullen said she received several compliments on the new playground.

#### FIRE DEPARTMENT PARKING LOT

Mr. Bushman submitted a preliminary list of considerations for the fire department parking lot. Mr. Teichman asked if the road department should begin patching the driveway. The Board asked him to wait one month as they were getting quotes to grind out the existing pavement. The Board may decide to do the work in sections. Footers and designated 18 x 18 pads for parking heavy equipment during training were discussed. Chief Lynn asked the Trustees to surface the parking area to the north of the fire station if nothing else was done this year.

## RESOLUTION 2015-25/JACLYN BREIER/GOLD AWARD

Resolution 2015-23 was made by Irene McMullen and seconded by Jim McCaskey to recognize Girl Scout Jaclyn Breier for her achievement of the Girl Scout Gold Award, with a unanimous vote. Motion carried. Ms. Breier created a Reflection Garden at NDCL for her project. The resolution in its entirety is included on a separate page as part of the minutes.

# RESOLUTION 2015-26/FUND TRANSFER

Resolution 2015-26 was made by Jim McCaskey and seconded by Irene McMullen for within fund transfers in the 2015 Permanent Appropriation in the General, Road and Bridge, and Cemetery Funds, with a unanimous vote. Motion carried. The resolution in its entirety is included on a separate page as part of the minutes. #### **AWARD BID FOR APHALT RESURFACING**

The Trustees reviewed the recommendations of the county engineer.

Jim McCaskey moved and Irene McMullen seconded to award a contract to Ronyak Paving, Inc. for the asphalt resurfacing of various roads in the amount of \$197,090, with a unanimous vote. Motion carried.

The Board authorized the fiscal officer to prepare the paperwork to renew the 1.75 mill fire and EMS levy for the November election.
