The meeting was called to order at 6:30pm by Chairman Irene McMullen with Trustees Andy Bushman and Jim McCaskey and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The minutes were prepared by fiscal officer elect Todd Ray.

For the record, because the nation is experiencing a pandemic, the meeting was held in observance of Ohio Department of Public Health guidelines for safe social distancing to reduce risk of transmission of COVID 19 corona virus between persons assembled in a public space. The meeting was conducted in the large meeting room, and agenda was limited to essential topics to limit the time of public gathering.

Mrs. McMullen opened the meeting with a brief statement acknowledging that this meeting was the final meeting for Fiscal Officer Judy Toth, and on behalf of the entire Board, Chair McMullen expressed her admiration and gratitude to Judy for her years of service to Township government. Mrs. McMullen noted that Judy served 27 years as township office manager, and was retiring after completing her eighth year as Fiscal Officer.

Trustees signed warrants 17210 - 17272 dated 3/24/2020, totaling \$423,057.28. The Board had signed EFT Vouchers 69-77 for the 3/20/20 bi-weekly payroll totaling \$9,064.10, EFT vouchers 96-104 for the 3/23/20 supplemental payroll totaling \$3,321.99, and EFT Vouchers 105-109 for the 3/31/20 monthly payroll totaling \$6,865.87.

MINUTES

Mr. Bushman moved to approve the minutes of the Trustees Regular meeting March 10, 2020, as written. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

CEMETERY DEED

The Board signed a deed to William Nyerges for Maple Hill Cemetery, Lot 350, Graves 1 & 2.

FIRE DEPARTMENT/CHIEF MIKE VATTY

Chief Vatty addressed the Board briefly, with an update on various ways that the MFD is preparing for the growing corona virus Covid19 epidemic, in consultation with the Geauga Health Department, Geauga Hospital staff, and state public health officials, now that Governor DeWine has issued the emergency Stay-at-Home order for all residents. The Department is anticipating the COVID 19 pandemic surge in the next two to three weeks. All prudent steps are being taken to protect first responders from exposure.

Chief Vatty discussed efforts to coordinate additional community resources to assist and support residents experiencing non-medical crises during the shelter-in-place period, specifically, collaboration with the Munson Road Dept. crew. Road Superintendent Walker and Chief Vatty agreed that the two Departments will provide reciprocal aid as challenges are encountered. Mr. Bushman provided a phone number for the Geauga Job and Family Services Emergency Committee. The Trustees expressed gratitude to all Road and Fire Dept. staff for the outstanding effort to prepare for the approaching crisis.

MOWING CONTRACTS

Mr. Bushman moved to approve mowing maintenance contracts for township properties, per the recommendation of Superintendent Walker. Mr. McCaskey seconded, and the motion carried with a unanimous vote. The Trustees approved contracts as follows:

Munson Valley Landscaping, for maintenance of the Town Hall grounds and Scenic River Park, in the amount of \$9,303.00;

Signature Lawns and Landscaping, for maintenance at the Township cemeteries and Nero Nature Preserve, in the amount of \$10,687.00;

S.A.M. Landscaping, for maintenance at Munson Township Park, in the amount of \$14,260.00.

Mr. Bushman moved to approve Resolution 2020-15, authorizing Munson Township to participate in procuring road salt through the Ohio Department of Transportation annual road salt bid in 2020. Mr. McCaskey seconded, and the motion carried with a unanimous vote.

RESOLUTION 2020-16 / ORDER THE RESURFACING OF VARIOUS ROADS

The Board addressed a Resolution to Order the Resurfacing of Various Roads in Munson Township, at a cost estimated at \$505,000. Jim McCaskey moved to approve Resolution 2020-16 to order the resurfacing of various roads to include Forest View Dr., Wood Hollow Dr., Sun Ridge Circle, Greenbrier Dr., Burlington Ridge Dr. and Burlington Glen Dr., as written. Mr. Bushman seconded, and the motion carried with a unanimous vote.

The Board addressed a series of scheduled Township events and the expected impact of the pandemic.

TOWNSHIP CLEAN-UP DAY

Mr. Bushman moved to postpone the Township Clean-up Day, scheduled for April 18, 2020, due to the pandemic, and to reschedule for September 19. Senior pick-up to be held September 14, 15, and 16. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

MEMORIAL DAY

Trustees noted concerns regarding public gatherings to celebrate Memorial Day, and questioned who would handle the planting of flowers at the cemetery during the pandemic. The Trustees agreed to move forward, and Mr. Bushman moved to purchase flowers for Memorial Day in the amount of \$710.10. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

EASTER EGG HUNT

Mr. Bushman moved to cancel the Township Easter Egg Hunt. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

COMMUNITY DAY PICNIC

The Board agreed to make no determination about the scheduled status of the Picnic.

GO GREEN COMMUNITY GRANT 2020

Mr. Bushman moved to approve the Go Green Community Grant for 2020, and to authorize Chair McMullen to sign on behalf of the Board. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

Mr. Bushman moved to authorize Pam Blair to refurbish/repaint eight "Entering Munson" signs, @ \$400 each. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

6:45 PM BID OPENING SPRING BIDS

The Trustees paused the business meeting to attend to the scheduled bid opening.

Andy Bushman moved and Mr. McCaskey seconded to waive the reading of the legal notice published in the *Geauga Maple Leaf*, for road materials, catch basins and headwalls, and virgin asphalt concrete, with a unanimous vote. Motion carried.
