Chairman Jim McCaskey called the meeting to order at 6pm with the Pledge of Allegiance.

#### **BICENTENNIAL**

Julie Johnston advised that the flyers are nearly completed for distribution at the schools and placement on the township web site. She will need more information about parking and shuttles to complete the flyer. The Committee discussed a banner to go across the street. The telephone poles match up at the corner of Auburn and Sherman Roads. Payne and Payne offered their parking lot for handicapped parking. Speakers were discussed. Zoning Inspector Tim Kearns placed notices in residents' newspaper boxes in the subdivisions off Auburn Road between Mayfield and Wilson Mills giving them advance notice that the event would be taking place. Notices will also be distributed on Fowlers Mill, Allen and Raymond. Bob Voss advised that Thomas Thornburg, who wrote a memoir on growing up on Fowlers Mill Road, will be in town during the event. Alpine Valley will be contacted regarding their quad lift. Lake Farmparks will not be able to provide their horses. Bob Voss will look into other alternatives for horsedrawn carriage rides. Julie Johnston had samples of commemorative items. Pencils and buttons would be the least costly. Line up for the parade will be 2:45pm with a tentative start time between 3 and 3:15pm. McCaskey had no success with the high school bands. Mr. Bushman said there would be a charge for the Fair Band to participate. The Park & Recreation Board, Tim Kearns and Lenore Pikus will be working on games. Paula Friebertshauser advised that she is working on historical displays and that she has completed a compilation of former Trustees and of the residents who received "Notable Township Resident" recognitions. She asked if the covered wagon would fit through the doors for display in the Town Hall lobby. Drew McLaughlin inquired if tee shirts would be provided for the event workers. The Committee will choose a bright color and those who wish can order them with the bicentennial logo. The next bicentennial work session will be Tuesday, June 7 at 6pm. Andy Bushman moved and Irene McMullen seconded to close the bicentennial meeting at 6:30pm, with a unanimous vote. Motion carried.

#### RESOLUTION 2016-15/ASPHALT RESURFACING ROCKHAVEN AND WYE

Shane Hajjar from the county engineer's office was present with the final plans for the asphalt resurfacing of Rockhaven and Wye in accordance with the discussions with the Township. The road department did the ditching, culvert and tree work. The bid opening will be Tuesday, June 7, 2016 at 3:05pm. The cost estimate for the project is \$200,000.

**BE IT FURTHER RESOLVED** that the Fiscal Officer of the Munson Township Board of Trustees is hereby ordered to let this project for bids in accordance with Section 5575.02 of the Revised Code. The bids shall be let upon a unit price basis. Bids shall be received by Judy Toth, Fiscal Officer, until 3:00 P.M. official local time on June 7, 2016. Bids received will be publicly opened and read aloud at 3:05 P.M. the same day.

# RESOLUTION 2016-12 AUTHORIZING PARTICIPATION IN THE ODOT WINTER CONTRACT (018-17) FOR ROAD SALT

WHEREAS, Munson Township in Geauga County (hereinafter referred to as the "Political Subdivision") hereby submits this written agreement to participate in the Ohio Department of Transportation's (ODOT) annual winter road salt bid (018-17) in accordance with Ohio Revised Code 5513.01(B) and hereby agrees to all of the following terms and conditions in its participation of the ODOT winter road salt contract:

- a. The Political Subdivision hereby agrees to be bound by all terms and conditions established by ODOT in the winter road salt contract and acknowledges that upon of award of the contract by the Director of ODOT it shall be bound by all such terms and conditions included in the contract; and
- b. The Political Subdivision hereby acknowledges that upon the Director of ODOT's signing of the winter road salt contract, it shall effectively form a contract between the awarded salt supplier and the Political Subdivision; and
- c. The Political Subdivision agrees to be solely responsible for resolving all claims or disputes arising out of its participation in the ODOT winter road salt contract and agrees to hold the Department of Transportation harmless for any claims, actions, expenses, or other damages arising out of the Political Subdivision's participation in the winter road salt contract; and
- d. The Political Subdivision hereby requests through this participation agreement a total of 700 tons of Sodium Chloride (Road Salt) of which the Political Subdivision agrees to purchase from its awarded salt supplier at the delivered bid price per ton awarded by the Director of ODOT; and
- e. The Political Subdivision hereby agrees to purchase a minimum of 90% of its above-requested salt quantities from its awarded salt supplier during the contract's effective period of October 1, 2016 through March 31, 2017; and
- f. The Political Subdivision hereby agrees to place orders with and directly pay the awarded salt supplier on a net 30 basis for all road salt it receives pursuant to ODOT winter salt contract; and
- g. The Political Subdivision acknowledges that should it wish to rescind this participation agreement it will do so by written, emailed request by no later than Wednesday, June 1, 2016. The written, emailed request to rescind this participation agreement must be received by the ODOT Office of Contract Sales, Purchasing Section email: <a href="Contracts.Purchasing@dot.ohio.gov">Contracts.Purchasing@dot.ohio.gov</a> by the deadline. The Department, upon receipt, will respond that it has received the request and that it has effectively removed the Political Subdivision's participation request. Furthermore, it is the sole responsibility of the Political Subdivision to ensure ODOT has received this participation agreement as well as the receipt of any request to rescind this participation agreement. The Department shall not be held responsible or liable for failure to receive a Political Subdivision's participation agreement and/or a Political Subdivision's request to rescind its participation agreement.


