The meeting was called to order at 6:30pm by Chairman Irene McMullen with Trustees Andy Bushman and Jim McCaskey and Fiscal Officer Todd Ray all present via Zoom electronic teleconference. Due to the ongoing viral disease pandemic, the meeting was held without any elected officials located in the same physical space. The meeting was open to the public, with the access link posted on the Munson Township website, in accordance with the Ohio legislature's Substitute Amended House Bill 197. Five residents logged into the meeting.

Chair Irene McMullen led the Pledge of Allegiance.

Trustees signed warrants 17348 - 17371 dated 5/26/2020, totaling \$30,308.90, and EFT Vouchers 156-163 for the 5/29/2020 bi-weekly payroll totaling \$8,405.08, and EFT vouchers 164 - 169 for the 5/29/20 monthly payroll. The April Financial Report is available for review by the Trustees.

MINUTES

Mr. Bushman moved to approve the minutes of the Trustees Regular meeting May 12, 2020, as written. Mr. McCaskey seconded; with a unanimous vote, the motion carried.

FIRE DEPARTMENT/CHIEF MIKE VATTY

Chief Vatty reported that things are going well within the Fire Department, with somewhat returning to normal. He noted that the Township has one fire levy that is eligible for placing on the ballot this fall as a renewal or replacement, one year ahead of its expiration. The MFD would like the Trustees to move forward with placing the levy on the ballot. Mr. Bushman asked Mr. Ray to determine the timeline for actions by the Board to assure the levy appears on the November ballot.

ROAD DEPARTMENT

Mrs. McMullen reported that the 1990 GMC Truck 102 has been sold.

TOWNSHIP BUSINESS

The Trustees discussed pest-control spraying quotes for Township properties, and agreed to stay with the vendor the Township has used in past years. Mr. Bushman moved to have the Township enter into the pest-control service agreement with Bill Horvath, not to exceed \$500. Mr. McCaskey seconded the motion. Motion carried with a unanimous vote.

Mr. Walker reported that the Kurtz Brothers has the best and lowest price on certified playground mulch specified by the risk management auditor, at \$23/yard, delivered. The Township will need 300 yards to meet standards. After discussion, Mr. Bushman moved to authorize the purchase of 300 yards of mulch from Kurtz Brothers, not to exceed \$7000. Mr. McCaskey seconded; motion carried with a unanimous vote.

The trustees discussed quotes for making changes to bathroom water facilities, retrofitting "touchless" accessories. Mr. Walker reported that a township resident, Tim Randles, of Monroe Plumbing, offered to install the upgrade plumbing fixtures at no cost for labor in the Munson Township Park bathrooms. Mr. Walker indicated that the Rd. Dept. crew could install filters that they believe will reduce maintenance issues with the touchless fixtures. Mr. Bushman moved to accept the quote from Monroe Plumbing not to exceed \$2010. Jim McCaskey seconded; Motion carried with a unanimous vote.

Trustees discussed options installing hand sanitizer stations in more locations in the parks and around township facilities. Trustees will revisit the topic later in the year. Mr. Walker reported that a number of vendors are preparing prices and options for hand sanitizer fixtures. Trustees discussed increasing access to sanitizer stations at more locations, such as courts and pavilions, but noted concerns about possible theft of the fixtures or their contents, and want secure devices. Mr. McCaskey noted that ideally, the sanitizer re-supplies would be included in ongoing cleaning/maintenance program in the parks. Trustees will gather more information before taking action.

COMMUNITY DAY PLANS

The Trustees discussed the scheduled Community Day Picnic, and agreed that public gatherings such as this are still risky. In order to give office staff direction on planning and preparation, the Trustees agreed to cancel the event. Mr. Bushman moved, to postpone the 2020 Munson Community Day Picnic due to the coronavirus pandemic. Mr. McCaskey seconded; motion carried with a unanimous vote.

Ms. McMullen pointed out that the Township has already received donations from four Munson businesses. She will write thank you notes to these generous donors to the Picnic, (Payne and Payne Builders, University Hospitals, Petersen and Petersen, and Junction Auto) and will invite them to redirect their gifts to the scholarship fund.

NOPEC GRANT- Streetlights

Irene McMullen updated the Board, stating that the next step in the process to convert the remaining streetlights to LED is the Board's authorization to have Illuminating Co. engineers prepare the engineering specifications for all the lighting upgrades. All three trustees supported moving ahead, and have Ms. McMullen communicate authorization to proceed.

The Trustees noted that the next Regular meeting is Tuesday, June 9, and considered holding the meeting in the community room, with expanded social distancing for all attendees. Mr. McCaskey stated that he felt it was time to resume meeting in the public space, using social distancing, noting that other county agencies have resumed face-to-face meetings. After discussion, Trustees decided to hold the next meeting by Zoom electronic teleconference.

FISCAL OFFICER

Mr. Ray explained that the County Auditor, following directives from the Auditor of State, expects each township to create a Special Fund to receive and track spending of the HHS CARES Act federal pandemic relief funds.

RESOLUTION 2020-23: Establish a Special Revenue Funds 2903

Andy Bushman moved to approve Resolution 2020-23, seconded by Jim McCaskey, to request the Auditor of State to approve establishment of Fund 2903, and to request the Budget Commission to certify additional revenue in the amount of \$7,593.84, and place it in Fund 2903. Mr. McCaskey seconded. Motion carried with a unanimous vote. [The resolution is included on a separate page as part of the minutes.]

RESOLUTION 2020-24 / WITHIN FUND TRANSFER

A motion to approve Resolution 2020-24 was made by Andy Bushman and seconded by Jim McCaskey for within fund transfers in the Permanent Appropriation in the General Fund, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

MONTHLY FINANCIAL REPORT

Mr. Bushman moved to approve the April Financial Report. Mr. McCaskey seconded, and the motion carried with a unanimous vote.

The Trustees agreed that the Township no longer needed to keep a safe deposit box at Middlefield Bank, and asked Mr. Ray to notify the Bank and take care of returning the key. Mr. Ray reviewed the timeline for preparing and approving the 2021 budget, and noted that the scheduled date for a workshop meeting, June 23, makes for a tight timeline for the Trustees to hold their public hearing and approve the budget to send to the Budget Commission.

Mr. Bushman moved to schedule a Special Meeting for a workshop to prepare the 2021 budget for June 16, at 6:30 p.m., location to be determined. Mr. McCaskey seconded. Motion carried with a unanimous vote.
