The meeting was called to order at 6:30pm by Chairman Andy Bushman, with Trustees Todd Ray and Irene McMullen and Fiscal officer Judy Toth present. The Chairman led the Pledge of Allegiance. Warrants 11836-11839 dated 11/22/13 totaling \$3,472.76 and EFT Vouchers 438-447 for the 11/22/13 bi-weekly payroll in the amount of \$10,344.83 were signed between meetings. Warrant 11840 was voided. Warrants 11841-11875 dated 11/26 and 11/29/13 totaling \$403,409.78, EFT Vouchers 451-455 for the 11/29/13 monthly payroll in the amount of \$7,476.53, and Warrant 1169 dated 11/26/13 in the amount of \$9,248.74, to transfer EMS funds from the lockbox to the primary account, were signed. Correspondence was on the table.

Todd Ray moved and Irene McMullen seconded to approve the minutes of November 26, 2013,

Motion carried.

### ROAD REPORT

Road Superintendent Jim Teichman asked the Board to encumber \$100 for handicap signs for the new parking lot. Ronyak Paving will paint the handicap insignia on the asphalt when the weather allows. He asked for authorization to close the entrance driveway to Nero Park and the driveway to the Scenic River pavilion and restroom for the winter. The drives will be reopened and plowed if there is a scheduled event. The Board agreed to the closures. Mike Grubb, a landscape architect and Munson resident, has offered to donate his time to work with road employee Mark Stukbauer to design the landscaping for the township hall. Jim McCaskey will also be included. The Board was pleased to accept his offer and asked that the plan be designed over the winter.

#### RESOLUTION 2013-55/CHANGE ORDER ASPHALT RESURFACING

Resolution 2013-55 was made by Mr. Ray and seconded by Mrs. McMullen to approve the change order for the asphalt resurfacing of various roads for a reduction to the contract in the amount of \$19,866.75, and to approve the invoice from Carron Asphalt in the amount of \$229,870.75, with a unanimous vote. Motion carried. [Original contract amount: \$249,737.50, Total ads, \$125, Total deducts \$19,991.75, Revised contract amount \$229,870.75.] The Board signed the change order.

### RESOLUTION 2013-51/ATKINSON COMMENDATION/MUNSON ZONING **COMMISSION**

State Senator John Eklund, Munson Township resident and former Munson Zoning Commission member, Zoning Commission members Dennis Medica, Lenore Pikus, and Tedd Berr, zoning inspector Tim Kearns, and zoning secretary Paula Friebertshauser were present to honor retiring Zoning Commission member Ron Atkinson.

Resolution 2013-51 was made by Todd Ray and seconded by Irene McMullen to commend Ron Atkinson for his 17 years of volunteer service on the Munson Township Zoning Commission, with a unanimous vote. Motion carried. [The resolution in its entirety is included on a separate page as part of the minutes.]

Senator John Eklund presented Mr. Atkinson with a certificate of commendation from the General Assembly of the Ohio Senate signed by Senator Eklund and Senator Keith Faber, President of the Ohio Senate. The meeting recessed at 6:52pm for refreshments and a tour of the new town hall, and reconvened at 7:17pm.

### TOWN HALL PROJECT

Mr. Bushman advised that the walk-through for the occupancy permit for the community room would be the following Tuesday. The Board discussed fire extinguishers and addressed the fire chief's suggestion that the extinguishers be recessed in the wall. The Board reviewed several samples of folding chairs for the community room and a black mesh folding chair, used by the Geauga Park District, for the Trustees' meeting room. The board will need thirty chairs for the meeting room. Mr. Bushman asked them to postpone a decision on the meeting room chairs to allow him to get samples of stack chairs.

Todd Ray moved and Irene McMullen seconded to approve the purchase of 13 black meeting table chairs FL9210 at the unit price of \$115 each, with a unanimous vote. Motion carried. Todd Ray moved and Irene McMullen seconded to purchase 125 folding chairs from Costco for the community room not to exceed \$2,500 with a unanimous vote. Motion carried.

#### RESOLUTION 2013-52/FUND TRANSFER

#### **DECEMBER MEETINGS**

Todd Ray moved and Irene McMullen seconded to cancel the regularly scheduled meetings on the 10<sup>th</sup> and 24<sup>th</sup> of December and to have special meetings on Tuesday, December 17<sup>th</sup> at 6pm and Tuesday, December 31<sup>st</sup> at 11am, with a unanimous vote. Motion carried.

#### **CIC MEMBERSHIP**

Todd Ray moved and Irene McMullen seconded to approve the township's membership in the Geauga County CIC [Community Improvement Corporation] for \$50. Roll call vote: Mrs. McMullen, yes; Mr. Ray, yes; Mr. Bushman, abstain. Motion carried. [Mr. Bushman is a board member.]

#### **CLEANING CONTRACTS**

The Board reviewed two quotes to clean the town hall. There was not much variance between the two quotes. The Board will table a decision to get more information.

### TOWN HALL DECORATING CONSULTANT

The Board agreed to thank Munson resident Cindy Bocchieri for her assistance with decorating decisions with a gift certificate. She will be given the same gift certificate choices as the appointed boards.

#### WALICK CEMETERY PLOTS

Todd Ray moved and Irene McMullen seconded to authorize the sale of cemetery plots to Chris Shannon Walick at the township rate of \$200 per plot, with a unanimous vote. Motion carried. SAM'S CLUB MEMBERSHIP

The Board addressed a memo from Secretary Julie Johnston asking if the Board wished to keep the Sam's Club membership and to pay the \$45 renewal fee.

Todd Ray moved and Irene McMullen seconded to approve the renewal of the Sam's Club membership in the name of Julie Johnston for a renewal amount of \$45, with a unanimous vote. Motion carried.

### **HEALTH INSURANCE RENEWAL**

The Board addressed an email from Sean Sprouse of the Burnham and Flower Agency. It will no longer be necessary to renew the township's insurance policy in December 2013 to keep the current coverage and the policy will revert back to its former renewal date of June 2014. Todd Ray moved and Irene McMullen seconded to rescind the motion made September 24<sup>th</sup> to approve the health insurance renewal date change, with a unanimous vote. Motion carried.

#### **COMMUNITY ROOM RENTAL**

The Board will continue to approve community room rentals for December at the current rates. Todd Ray moved and Irene McMullen seconded to approve the community room rental agreement for a Girl Scout holiday party (Myers) on December 12, 2013 from 6 -9pm, approx. 35, and to waive the fees, with a unanimous vote. Motion carried.

Todd Ray moved and Irene McMullen seconded to approve the community room rental agreement for a Polka Party (Kouwe) December 22, 2013 at 7pm, approx. 100, for a \$100 fee and \$250 security deposit, with a unanimous vote. Motion carried.




