The meeting was called to order at 6:30pm by Vice-Chairman Irene McMullen with Trustee Andy Bushman and Fiscal Officer Judy Toth present. Trustee Jim McCaskey was absent. Mrs. McMullen led the Pledge of Allegiance.

### **PUBLIC COMMENT**

Residents were present to inquire about the Bethlehem Hills light show at Berkshire Hills Country Club. Joe Bastulli acknowledged the Trustees special meeting with the prosecutor last evening and asked what they could share. Section 519 is still on the books and the light show begins next week. Joe Otto asked for clarification on 519 and who may initiate a zoning amendment. Mr. Bushman reviewed the process. Joan Otto pointed out that the Township was under the original zoning laws since there was no change. Mr. Bastulli was concerned that Berkshire Hills would be allowed to plan other activities. Dawn Bastulli pointed out that this has been going on for a year with no resolution, and the residents urged the Trustees to resolve the issue.

Mr. Bushman will discuss these options with the Fire Department.
