Meeting

Chairman Andy Bushman called the meeting to order at 6:30 pm, with Trustees Irene McMullen and Fiscal Officer Todd Ray present. Mr. Bushman led the Pledge of Allegiance.

Mr. Bushman stated that the Trustees had warrants to sign. Trustees signed warrants 18320 - 18353 dated 10/12/2021, totaling \$204,729.70, and the October 15, 2021, bi-weekly payroll EFT vouchers 357 through 364, totaling \$7,466.96.

Public Comment

Chair Andy Bushman called for any public comment from meeting attendees. No one in attendance offered comment.

FIRE DEPARTMENT

Fire Chief Mike Vatty reported that the Call volume for the year continues to be back up to typical level and is heading toward 1,250 calls for the year. He reported that the new ambulance (squad) on order is scheduled for delivery, possibly in two weeks.

Trustees addressed the matter of the water softener system for the Fire Station and Town Hall. Irene McMullen moved to approve the purchase and installation agreement for a water treatment system with Sunrise Springs, not to exceed \$9,500.00. Andy Bushman seconded the motion. With a unanimous vote, the motion carried.

ROAD DEPARTMENT

Road Superintendent Kirk Walker noted that the remodeling project in the Road Maintenance Building is about ready to go to bid. The crew hope to begin demolition phase as soon as this fall, pending the outcome of bids.

He updated the Board on enhanced safety measure at the intersection of Fowler's Mill Rd. and Sherman Road.

TOWNSHIP BUSINESS

RESOLUTION 2021-33 / Establish Speed Limit on Klatka Drive

Chair Andy Bushman noted that the Trustees have completed observations of traffic on Klatka Drive in the past two weeks, as due diligence to consider a request to reduce the posted speed limit on that sub-division road.

Andy Bushman moved to approve Resolution 2021-33, the reduction of the posted speed limit on Klatka Dr. to a maximum of 25 miles per hour, including the installation of appropriate signs on the roadway. Irene McMullen seconded the motion. With a unanimous vote, the motion carried.

Township Park Scoreboards

Andy Bushman provided an update on the process to have scoreboards installed at Munson Township Park for the ballfields used by Chardon High School varsity softball and baseball. The scoreboards are ordered, with a delivery date not sooner than mid-January 2022. The location of the foundations for the scoreboards have been marked on the ground on site. He met with the vendor to set details for installation of underground conduit and wiring to power the scoreboards; the cost of the underground cable will determine final costs.

Ballfield maintenance

Ms. McMullen moved to approve a proposal for renovation and maintenance work on Zambory Field in Munson Township Park by P. Ianiro Lawn and Garden, Inc. not to exceed \$8,291.25. Andy Bushman seconded. Motion carried with a unanimous vote.

NOPEC proxy

Ms. McMullen moved to approve a proxy vote for Munson Township at the NOPEC annual meeting. Andy Bushman seconded. Motion carried with a unanimous vote.

Leave accrual

Ms. McMullen moved to approve the accrual of sick and vacation leave during Munson Township employee Josh Helm's medical leave. Andy Bushman seconded. Motion carried with a unanimous vote. Trustees will revisit the matter at a November meeting.

He noted that many pedestrians walk along the roadway, several with their dogs, and he feels the traffic speed warrants consideration for a lower posted speed limit. The Trustees noted that any action to lower the posted limit would require the agreement of Chester Township Trustees because responsibility for Heath Road is shared with Chester Township. Chair Bushman will reach out to Chester Trustees to discuss the matter.

Munson Township Board of Trustees Resolution No. 2021-33

RESOLUTION REDUCING THE PRIMA FACIE SPEED IN A RESIDENTIAL SUBDIVISION PURSUANT TO §4511.21 OF THE OHIO REVISED CODE

WHEREAS, the Munson Township Board of Trustees is of the belief that the statutory speed limit of 55 miles per hour (mph) is greater than is reasonable and safe for Klatka Drive; and

WHEREAS, this Board has caused to be made an engineering and traffic investigation upon the section described above, and

WHEREAS, it is the belief of this Board that such investigation confirms the allegation that the statutory speed limit is unrealistic.

WHEREAS, §4511.21 of the Ohio Revised Code authorizes the Board of Trustees to declare a safe and reasonable prima facie speed limit in residential subdivisions.

NOW THEREFORE, BE IT RESOLVED by the Munson Township Board of Trustees that the Board hereby declares that a reasonable and safe prima facie speed limit for Klatka Drive shall be 25 mph;

BE IT FURTHER RESOLVED that standard signs, properly posted and giving notice of the prima facie speed limit of 25 mph shall be erected; this Resolution shall become effective once said signs are erected.
