The meeting was called to order at 6:30pm by Chairman Jim McCaskey with Trustees Andy Bushman and Irene McMullen and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Board signed warrants 16931-16950 dated 10/22/19 totaling \$18,128.19 and EFT Vouchers 390-397 for the 10/18/19 bi-weekly payroll for \$8,204.29.

#### **BEST SAND APPRECIATION LETTER**

The Board signed a letter of appreciation to Covia/Best Sand for donating the structure for the fire department's live-burn training event, and for providing the funding for the permitting fees and asbestos removal.

#### **CEMETERY DEED**

The Board signed a deed to Philip H. and Rachel A. Webster for Maple Hill III Cemetery, Lot 348, Graves 7 and 8.

#### **MINUTES**

Irene McMullen moved and Andy Bushman seconded to approve the minutes of October 8, 2019, with a unanimous vote. Motion carried.

#### AWARD PRESENTED

Acting Chief Mike Vatty introduced Dr. Donald DeCarlo and EMS Director Dan Ellenberger from University Hospitals – Geauga. Mr. Ellenberger presented the American Heart Association Mission Lifeline Quality Achievement Silver Award to the Fire Department for exemplary cardiac response. He praised the fire department. The hospital cannot give good care without the initial response of the fire department. After the plaque was presented, pictures were taken of the UH representatives and fire department members.

#### **PUBLIC COMMENT**

Resident Dawn Bastulli pointed out that it was mid-October and she was still waiting for a response regarding the light display at Berkshire Hills. She reviewed her objections to the light show and wanted to know why the Township could not respond to her questions. Mr. McCaskey told her that the Board had spoken with assistant prosecuting attorney Susan Wieland and met with her in executive session on October 10. He asked Mrs. Bastulli to have residents direct any questions to him. Resident Rich Ferlin agreed this had been going on for a while, questioned if Mr. McCaskey had the authority to speak for all three Trustees, and pointed out that the next Trustees meeting was November 12. Mrs. McMullen noted that the Board recently received a communication from the attorney. Mrs. Bastulli said they were asking the same questions. Resident Debbie Roche asked if the Board had anyone to whom they could complain if they were not getting answers. Mr. McCaskey advised he had spoken with Prosecutor Jim Flaiz, and Mr. Bushman noted the Board had two special meetings trying to push the matter.

# FIRE REPORT/ACTING CHIEF MIKE VATTY

Acting Chief Vatty reported FEMA rejected the fire department's application for a grant for a new tanker. To qualify, the majority of the fire department's vehicles must be over 20 years old. They will attend a session regarding agritourism. Because agricultural uses are not regulated by zoning, enforcing the fire codes will be important. Captain Gray received his certification as a fire and life-saving inspector. The fire department responded to an incident in which a kayak overturned in water. Auburn Township provided their boat for the rescue. Munson's rescue boat will be here November 1.

#### ROAD REPORT/SUPERINTENDENT KIRK WALKER

Mr. Walker had nothing new to report for this meeting. Striping is scheduled and will be done weather permitting.

## **TOWNSHIP COMPUTERS**

The Board reviewed a quote for two new laptops and for computer upgrades. Mr. Bushman advised that Windows 7 is expiring at the end of the year.

Irene McMullen moved and Mr. Bushman seconded to contract with GPC Tech Team for computer upgrades in an amount not to exceed \$2,600, with a unanimous vote. Motion carried.

A RESOLUTION OF THE TOWNSHIP OF MUNSON, GEAUGA COUNTY, OHIO AUTHORIZING THE ESTABLISHMENT OF A SECTION 125 CAFETERIA PLAN FOR EMPLOYEES.

WHEREAS, Munson Township provides employees with certain benefits, including partially funded health insurance; and

WHEREAS, each covered employee must contribute to this plan; and

WHEREAS, employee spending on health care and related services can be significant; and

WHEREAS, Section 125 of the Federal Revenue Act of 1978 authorizes the establishment of Section 125 Cafeteria Plans for public sector employees; and

WHEREAS, such a plan allows employees to pay for certain eligible expenses on a pre-tax basis, thereby saving both the employee and Munson Township the cost of certain taxes, including payroll taxes.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Munson Township that Munson Township is hereby authorized to establish and implement a "Section 125 Cafeteria Plan" for its employees, in accordance with provisions of Section 125 of the Revenue Act of 1978.
