

Minutes of the Munson Township Park & Recreation Board Meeting

Tuesday, March 11, 2014

The meeting was called to order at 6:30pm by Art Hollis.

Present: Art Hollis (Chairman), Claudia Toth (Vice), Jim O'Neill, and Joe Rosboril.

MINUTES

Claudia Toth made a motion which was seconded by Joe Rosboril, to approve the meeting minutes from February 11, 2014. Passed unanimously.

OLD BUSINESS:

Indoor Flea Market

Indoor Flea Market results were passed out to Park Board members (attached to minutes).

Current project review

Playground – Park & Recreation Board members reviewed playground photos, layouts and estimates from Institutional Diversified, Meyer Design and Snyder & Associates. Meyer Design is the only company of the three that do their installations in-house. Playground benches will be an Eagle Scout project so the Township can remove that cost from the estimates. Park Board members recommend Meyer Design and will present the estimates to the Trustees at their March 25, 2014 meeting. Claudia Toth made a motion which was seconded by Jim O'Neill to recommend Meyer Design for the playground at Munson Town Hall. Passed Unanimously

Bleachers – When weather allows, Joe Rosboril will measure the bleachers and proceed with this project. Mr. Rosboril will look into both new and retro fitting to see which would be the best alternative. Three sets of bleachers are needed at the baseball fields at Town Hall Park. The Park Board hopes to have the new bleachers operational by the start of baseball season which is typically May 1st.

Work session with Trustees for 2014 remaining projects

The joint meeting with the Trustees on March 4, 2014 was productive. Park & Recreation Board members feel there should be a joint meeting scheduled twice each year.

Candy bags for Easter Egg Hunt

The Easter Egg Hunt is scheduled for Saturday, April 19, 2014 at 10:30 am at Munson Township Park. Jen Evans and her Girl Scout Troop will be filling the candy bags this year for the Easter Egg Hunt.

They will present a list of ideas to the Trustees at an upcoming meeting.
