This project will depend largely on how many asphalt grindings the Road Department will acquire during road projects this year.

The Trustees will most likely move forward with the pickleball courts once the quoted price (from 2021) is confirmed it will remain the same. At that point, the Board of Trustees will need to approve the contract before the work can begin. The tennis courts, basketball courts and pickleball courts will probably be done all at the same time.
