MINUTES

Claudia Toth made a motion which was seconded by Jim O'Neill, to approve the meeting minutes from October 14, 2014. Passed unanimously.

NEW BUSINESS:

Review workshop with Trustee's

Members have a better idea of what they are expected to do. The Trustees do not want members to be in charge of park maintenance and things of that nature. Claudia Toth will look at the parks and their trails to try to get something done. The Park Board will no longer be involved with the planning of the Flea Markets although they will be glad to volunteer at the events. Communication between the Trustees and Park & Recreation Board members needs to improve. Changing their meeting day will be a good start. All members agreed to hold their meeting on the second Monday of each month at 6:15pm. This change will allow the Park & Recreation Board to attend the Trustee Meeting the following evening. The next meeting will consist of putting items that need to be done in writing. Some of the other points talked about are as follows: Winter Event - The idea to do something at Scenic River during the winter months may come up within the next couple of years. Bird Gel - The bird gel that was applied in the spring to the pavilions did not work as advertised. The bird dropping issues have not improved or been resolved. Eagle Scout - Park & Recreation Board members will make a list of ideas for future Eagle Scout projects. The projects need to be approved through a district committee before they can bring it to us. Benches are needed at Town Hall for the new playground and at Munson Township Park. Landscape Quotes - Members would like them to go out for bid sooner. Copies of the contracts will be given to members after they have been awarded so they can make sure that the work is completed as the contracts state. Old Playground Equipment - swing sets need a 40x40 section with eight to nine inches of mulch. Park & Recreation Board members would like to know when the inspections are and would like a copy of the report. Tennis Courts - The tennis courts need attention and the board will look at them in the spring. New tennis courts will most likely use up the entire budget which has not been allotted yet. Park Check Lists - Park & Recreation Board members would like to reinstate park check lists that were used years ago. Park Secretary, Julie Johnston will try to locate the forms.
