**NEW BUSINESS**

Flea Market review

The expense/net proceed report for the Indoor Flea Market was passed to Park & Recreation Board members (attached). Net proceeds will go to the Munson Township scholarship fund. Suggestions for future flea markets are as follows: raise the cost of spaces from \$15 to \$20 or \$25 and/or charge shoppers an entrance fee of \$1 per person. Since the fire trucks must be outside in order for flea market space to be in the fire bay, the Indoor Flea Market will most likely be held in March next year due to the cold weather conditions this year.

Easter Egg Hunt- April 4, 2015

Girl Scout Leader Jen Evans will be contacted to see if she and her troop will be able to stuff candy bags for the Easter Egg Hunt again this year. Not knowing what the weather will hold or if the snow will be melted in time for the event, Park & Recreation Board members have suggested plan B if the grounds are not ready for the hunt: scatter the eggs in Pavilion #2 parking lot or on the tennis courts with a straw path leading to them to help cut down on mud. Park & Recreation Board members will meet at Munson Township Park at 9am the morning of the event for set up.

Munson baseball fields

Joe Rosboril contacted a member of the baseball league committee in regards to field preparation. Mr. Rosboril was told that the league and will be meeting soon and they will get back to him. Park & Recreation Board members learned that the Baseball Commission contacted Munson Township Trustees. Members are not clear on who is going to get the fields ready and who the responsible party is.


