**MINUTES**

Joe Rosboril made a motion which was seconded by Claudia Toth, to approve the meeting minutes from June 11, 2013. Passed unanimously.

**OLD BUSINESS:**

2013 Projects

a. Trails at Nero Nature Preserve – Joe Rosboril will work on this and pick up where Bob Marn left off.

b. Fireplace at Scenic River Retreat – Art Hollis retrieved five preliminary estimates ranging from \$18,000 to \$27,600. The quotes may change once he finds out if there are footers and where they are located. The Park Board in visions a fireplace in the middle with a wood box on both sides. The preliminary estimates may change once a footer determination is made, stone is chosen and hearth and mantle decision is made.

Park Board members narrowed the five preliminary estimates down to three which are as follow: 1) Greenovations, \$20,700, referred by New Vista Enterprises 2) Green Estates Inc., \$17,000 (fireplaces), \$1,050 (wood boxes), referred by Geauga County Park District, 3) Marlin, \$17,860, (if a footer is needed, an additional \$4,160), referred by Payne and Payne.

Builders. Joe Rosboril made a motion to present the preliminary estimates from Greenovations, Green Estates Inc. and Marlin to the Trustees to move forward with the fireplace at Scenic River Retreat which was unanimously approved.

c. Parking lot paving and sewers – Nothing to report at this time.

**OTHER BUSINESS**

Circus

There is damage from the large animals and trucks on the grounds at Munson Township Park left by the Circus on July 23 and 24, 2013. The repairs have not been made yet. Drainage pipes were driven over and possibly broke. Joe Rosboril and Art Hollis will inspect the park to see if repairs have been made.

Pavilion research on birds




**ADJOURNMENT:**
