

Munson Township Park & Recreation Board Meeting

Wednesday, August 31, 2011

The meeting was called to order at 5:30pm by Chairman Joe Rosboril. The minutes were taken by Michael Roche.

Present: Kristen Bluemmel, John Kaczynski, Robert Marn, Tim Kearns, Michael Roche, Joe Rosboril, Jonathan Schroeter. Absent: Barbara Parkinson, Mark Stukbauer. Others in attendance: Paula Friebertshauser, Judy Toth, Andy Bushman.

Minutes

Kearns moved and Schroeter seconded to approve the June 15, 2011 minutes, as written. Passed unanimously.

Bluemmel moved and Marn seconded to approve the July 20, 2011 minutes, as written. Passed unanimously.

Community Day Picnic

Less money was spent this year, approx. \$7,482.80, due to higher donations (pasta salad and \$500 grand prize) and less cost for prizes. Approx. 850 attended.

\$4,224 was raised for scholarships plus a \$1,000 donation from Fairmount Minerals (Best Sand), \$5,224 total. Suggestions for improvement: involve the road crew in cleanup the day of the picnic, change up with a different band next year. The consensus was that the picnic was well done and appreciated. The next picnic will be scheduled for the first weekend in August.

Kearns moved and Rosboril seconded to request authorization to purchase an additional sign, with a unanimous vote. Motion carried.

Township Park Parking Donation

Board addressed an offer by Matthew Knecht to donate up to \$2,500 for additional parking at the tennis courts. A fence was discussed. Need to configure area and get the township trustees' approval. A variance will be required. The park board will work up a recommendation. Bluemmel moved and Kaczynski seconded to request additional parking for the tennis courts. Passed unanimously.

A fence for the basketball court was discussed.

Kearns moved and Marn seconded to recommend a fence for the basketball court. Passed unanimously.
