Bluemmel brought in a request from the new program director at the YMCA to use one of the baseball fields in the Munson Township Park for their fall baseball events September 5 through October 30. They would use the facility two times a week plus Saturday. Bluemmel moved, seconded by Parkinson, to recommend to the Munson Township Trustees to grant this request. Passed unanimously.


Marn noted that the Nero Nature Preserve is looking good. However, he noted that the trail ends are not identified.

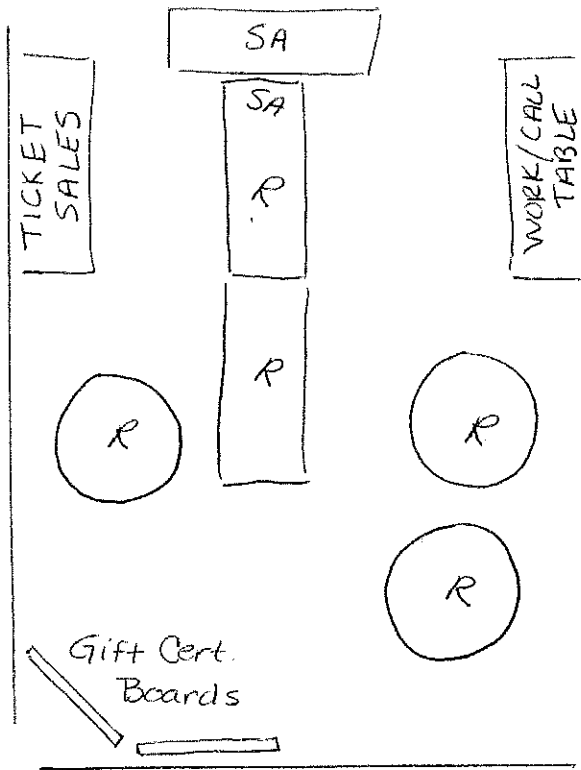
