Meeting

The meeting was called to order at 6:30pm by Chairman Jim McCaskey with Trustees Andy Bushman and Irene McMullen and Fiscal Officer Judy Toth present. The Chairman led the Pledge of Allegiance. The Trustees signed warrants 14448-14459 dated 9/27/16 and 9/30/16 totaling \$120,704.74, EFT Vouchers 795-799 for the 9/30/16 monthly payroll totaling \$7,007.41, and warrant 1235 for \$4,927.78 to transfer EMS collections from the lockbox. CEMETERY DEED

Cemetery deeds were signed to Timothy J. and Debra A. Garlak, Maple Hill III, Lot 346, Graves 10 & 14, and Suzanne J. Storey, Maple Hill III, Lot 338, Graves 10 & 11.

FIRE REPORT/CHIEF MARK LYNN

Chief Lynn reported they are fine-tuning the grant for the breathing apparatus and have a phone conference with FEMA on Monday. The other participating departments have secured their funding. Payne and Payne, the new owners of the property at the corner of Fowlers Mill and 322, have begun cleaning up the buildings and grounds. He reminded the Trustees that the fire station carpet has not been replaced, which was part of the insurance settlement for the ice damage. Mr. McCaskey will follow up. The department will hear back from ISO in four to six months regarding the Township's rating. He did not expect the rating to change.

ROAD REPORT/SUPERINTENDENT JIM TEICHMAN

Mr. Teichman submitted quotes to weed and fertilize the ball fields and to stripe Sherman, Fowlers Mill, Rockhaven and Woodiebrook Roads.

Andy Bushman moved and Irene McMullen seconded to approve Elliott's LawnCare LLC not to exceed \$640, with a unanimous vote. Motion carried.

Andy Bushman moved and Irene McMullen seconded to encumber \$11,500 to Aero Mark for striping, with a unanimous vote. Motion carried.

HB 523 MEDICAL MARIJUANA

The Trustees addressed a recommendation from the Munson Zoning Commission to issue a twelve month moratorium on the cultivating, processing, or selling of medical marijuana. They also recommended the option to extend the moratorium as deemed necessary for the immediate preservation of the public health, safety, and welfare of the Township. Mrs. McMullen will consult the prosecutor's office before the Trustees take action. Medical marijuana will be a topic of discussion at the next Geauga County Township Association meeting.

APPOINTED BOARDS

The Trustees discussed the candidates for the appointed boards and when the positions would become available.

ZONING INSPECTOR POSITION

Zoning Inspector Tim Kearns will retire effective December 31st. The Trustees will notify the current Zoning Boards about the open position. The office manager will also be asked to provide the Trustees with a draft letter and a list of Board members from the past four years. ENGINE BRAKES

The Trustees addressed a request from Dennis Laughlin for a "no engine brake" sign for the corner of Wilson Mills and Auburn. Because they are county roads, Mrs. McMullen will follow up with the County Commissioners.

TIME CAPSULE

The Board will need a list of the items to be included in the Bicentennial time capsule in order to determine its size. They planned to bury the capsule this year.

RESOLUTION 2016-31/FUND CERTIFICATION AND PLACEMENT

Resolution 2016-31 was made by Andy Bushman and seconded by Irene McMullen to request the Budget Commission to certify additional revenues in the Zoning Fund and Fire Operating and Apparatus Fund, and to place them in various line items in the Permanent Appropriation, with a unanimous vote.
