The meeting was called to order at 6:31pm by Chairman Todd Ray, with Trustees Andy Bushman and Irene McMullen and Fiscal Officer Judy Toth also present. The meeting opened with the Pledge of Allegiance. The Trustees signed warrants10360-10393 dated 5/8 & 5/11/12 totaling \$27,200.84, EFT Vouchers 2044-2052 for the 5/11/12 bi-weekly payroll in the amount of \$8,985.49; and Warrant 1132 dated 5/8/12 in the amount of \$5,183.50 to transfer EMS collections from the lockbox to the primary account. Correspondence and the Fiscal Officer's monthly report for April were available for review.

MINUTES

Andy Bushman moved and Irene McMullen seconded to approve the minutes for April 24, 2012, as corrected, with a unanimous vote. Motion carried.

CEMETERY DEEDS

The Trustees signed cemetery deeds to Martin Joseph Wagner for Maple Hill III Cemetery, Lot 334, Grave 3; Evelyn Yvonne Wagner, Maple Hill III Cemetery, Lot 334, Grave 4; Brendan Hurd Wagner, Maple Hill III Cemetery, Lot 334, Grave 5; and Anna Catherine Wagner, Maple Hill III Cemetery, Lot 334, Grave 6.

RESOLUTION 2012-19/LOCAL CABLE PROGRAMMING

Resolution 2012-19 was made by Mr. Bushman and seconded by Mrs. McMullen to renew the contract with Geauga Local Access Cable Corporation to provide local access programming in Geauga County, commencing April 12, 2012, with a unanimous vote. Motion carried.

PUBLIC COMMENT

Mr. Ray asked if there was public comment from any resident who had an issue that was not on the agenda. Ed Kavick, 12310 Bean Road, discussed the ditch work done by the township at his residence. He said he was unable to mow the new area because of the high wall bank, and that water pools in the ditched area. He has been maintaining the ditch himself for 45 years and asked the board to restore it to its former condition. Road Superintendent Teichman explained that the ditching was done to ensure that the pipes were open and carried the water. A minimal amount of area was disturbed. A longer back slope would have impacted the yard more. The grass trapped the water, sediment, and cinders, and the pipe started to fill in, which raised the level of the ground next to the pipe. The Trustees have viewed the site, but have not been able to observe it during a rain storm. Mr. Teichman suggested that the ditch be made shallower by cutting it back into the yard. Mr. Kavick agreed that a more gradual transition would be a solution and that the additional exposed soil would not be a problem.

TOWNSHIP HALL ADDITION

Architect Hank Penttila distributed a revised drawing. He revisited the project after conversing with his structural engineers. The walls of the existing building are not structurally capable for this extensive of a renovation and will not be able to handle the structural load without considerable investment. The more extensive renovation would also require the staff to abandon the building for several months at additional expense and inconvenience. After speaking with his consultants, he recommended that the shell of the building be left alone, and the space renovated within for the staff and township operations. The new addition will be for the community room and entrance. The existing building will be made more energy efficient. He discussed the existing walls and the insulation that would be required, additional framing for electrical services, finish walls, window opening enlargement, and window replacement. The ducts will be rearranged to increase the ceiling height. Lighting will be upgraded. The new plan will be less expensive than Plan A. Mr. Penttila has not had an opportunity to address the fire station roof with the new configuration and will bring his recommendations and his cost estimates for the entire project to the next meeting. Mr. Ray inquired about gable ends. Mr. Bushman inquired about moving the location of the new restrooms from the lobby to the community room.

Andy Bushman moved and Irene McMullen seconded to allow Hank Penttila to proceed with Plan C, with a unanimous vote. Motion carried.

The architect will email the plans to the township for placement on the township web site. FIRE DEPARTMENT

Fire Chief Bernie Harchar reported the fire department responded to a fire in Newbury Township over the weekend. Last year there were fewer than 3 grass fires. He credited better public education and an effective permit system. The fire contract ends May 31. The Board discussed setting up a workshop.

ROAD REPORT

Road Superintendent Jim Teichman met with OTARMA loss control consultant Kelly Austin after her inspection of the township playgrounds, and submitted a memo outlining her recommendations. Nine inches of certified mulch is required for the playgrounds and vita course. Rubber chips are the best, but the most expensive. The required minimum spacing between each apparatus is 6 feet. Sand and loose material is not acceptable for young children up to 2-1/2 years old. Signage is needed for the age appropriateness of play equipment. Public playgrounds are those used by children ages 6 months through 12 years. The addition of back and side panels is recommended for the bleachers. The bleachers must be analyzed to see if they can bear the additional weight. It may be necessary to replace the bleachers or to cut them down to two risers. The information will be forwarded to the park board. Mr. Teichman showed the board pictures of large items that were dumped at the recycling site. Mr. Ray suggested that the surveillance tapes be reviewed.

Teichman requested a new 48" wide ditching bucket for the loader/backhoe.

Andy Bushman moved and Irene McMullen seconded to purchase a new 48" ditching bucket with an optional bolt on edge for \$1,800.00 from Southeastern Equipment, with a unanimous vote. Motion carried.

Teichman advised two panels were removed at the end of the recycling fence for rubbish day and will need to be replaced. He also recommended that two additional panels be added to extend the fencing and that steel sleeves be installed to allow the department to remove and replace the end panels as needed for rubbish day.

Andy Bushman moved and Irene McMullen seconded to allow Auburn Fence to install two more panels and to reinstall the two panels that were removed for rubbish day not to exceed \$625.00, with a unanimous vote. Motion carried.

Andy Bushman moved and Irene McMullen seconded to purchase a radiator for Truck #106 from Lake Truck Sales and Service not to exceed \$2,050, with a unanimous vote. Motion carried. Teichman reported that the mulching is done at the township parks and requested \$576 for an additional 20 yards of mulch for the township hall, triangle, and cemeteries.

Andy Bushman moved and Irene McMullen seconded to purchase more mulch for the cemeteries, town hall, and triangle from Munson Valley not to exceed \$576, with a unanimous vote. Motion carried.

Teichman had three estimates for a 9 foot power broom. During use, one foot is lost with the angle. The cost for a 10 foot broom would be an additional \$150. However, the 10 foot unit would be too large for the smaller trucks.

Andy Bushman moved and Irene McMullen seconded to purchase a 9 foot wide truck-mounted broom from Southeastern Equipment not to exceed \$10,000, with a unanimous vote. Motion carried.
