The meeting was called to order at 6:30pm by Chairman Irene McMullen with Trustees Andy Bushman and Todd Ray and Fiscal Officer Patricia Bayer present. The Pledge of Allegiance was recited. Warrants 9602-9621 dated 7/18, 7/19, and 7/22/11 totaling \$40,943.41 were signed between meetings. Warrants 9622-9665 dated 7/26 and 7/29/11 totaling \$153,283.28, EFT Vouchers 1750-1759 for the 7/22/11 bi-weekly payroll in the amount of \$10,298.19 and 1760-1765 for the 7/29/11 monthly payroll in the amount of \$8,005.05, and Warrant 1113 in the amount of \$13,021.90, to transfer EMS collections from the lockbox to the primary account, were signed. Correspondence was available for review. The board signed a contract with S.A.M. Landscaping to install drainage at the Munson Township Park tennis courts.

MINUTES

Mr. Ray moved and Mr. Bushman seconded to approve the minutes of May 14, 2011, as written, with a unanimous vote. Motion carried.

Mr. Ray moved and Mr. Bushman seconded to approve the minutes of June 21, 2011, as corrected, with a unanimous vote. Motion carried.

Mr. Ray moved and Mr. Bushman seconded to approve the minutes of July 7, 2011, as written, with a unanimous vote. Motion carried.

ZONING

Zoning Inspector Tim Kearns informed the board that he received a final notice from Geauga Soil & Water that the corner of the township hall property which was cleared and seeded is in compliance. Fairmount Minerals [Best Sand] purchased the Black Lab Company on Ravenna Road and will need to contact the zoning office regarding their Conditional Use. Mr. Kearns followed up on complaints from Munson residents regarding the group home on Walnut Trace located in Newbury Township. He met with the residents and the property owner, who agreed to address the residents' concerns. The NEROCO and Klingmann properties will be put on the agenda for the next meeting.

SCENIC RIVER E-LOO RESTROOM PROJECT

Mr. Kearns advised that the Scenic River restroom project will need an Ohio EPA permit. Land Design prepared the paperwork for the township at no charge and it is ready for submission. Mr. Ray moved and Mrs. McMullen seconded to approve the application for a permit from the Ohio EPA for the Eloo Project and to include payment of the Ohio EPA fee of \$304. Roll call vote: Mr. Ray, yes; Mrs. McMullen, yes; Mr. Bushman, no. Motion carried. Mrs. McMullen signed the application.

ROAD REPORT

The culvert replacement project at the corner of Millstone and Bean Road has been completed. Mr. Ray moved and Mr. Bushman seconded to approve the excavation for the culvert project at the corner of Bean and Millstone by Trushel Excavating not to exceed \$5,150, with a unanimous vote. Motion carried.

Road Superintendent Jim Teichman submitted government bid quotes from Jones Equipment, and quotes from Henderson of Ohio and Concord Road Equipment for a dump bed, hydraulics, and accessories for the new truck.

Mr. Ray moved and Mr. Bushman seconded to approve the installation for the dump bed for the new truck by Concord Road Equipment for \$1,225.27, with a unanimous vote. Motion carried. Mr. Ray moved and Mr. Bushman seconded to accept the package of accessories for installation by Concord Road Equipment in the amount of \$1,559.06, with a unanimous vote. Motion carried

Mr. Ray moved and Mr. Bushman seconded to approve the load sensing hydraulic system with transmission rear mounted PTO, by Concord Road Equipment in the amount of \$14,298.56, with a unanimous vote. Motion carried.

Mr. Teichman asked the board for a \$75,000 carryover for next year for micro-surfacing. He requested \$11,400 for the application of the bio based green asphalt rejuvenator RePlay on Nicoles Way, Raymond Drive, Allen Drive, Flat Rock Drive, Holden Ridge, Autumn Ridge, and Julie Drive. He reported that the second coat of asphalt was put down on Legend Creek Drive. Berming still needs to be done.

RECYCLING AREA FENCING

Mr. Teichman showed pictures of four different styles of fencing for the recycling center. He submitted a quote of \$1,689 for 27 sections of solid flat panel Halifax style fencing. The quote does not include brackets or caps. The board will discuss the fence with the neighboring property owner. Mr. Bushman suggested fencing on three sides of the recycling area instead of along the neighbor's property.
