All members voted yes, 4-0, motion carried.

## ZONING INSPECTOR'S REPORT

Mr. Kearns distributed the October Zoning Certificate listing. When asked about the old jail site on Route 44, Mr. Kearns said he provided some suggestions to the County. Mr. Atkinson mentioned that there is a potential buyer who wants to convert the current zoning to medical, which would have to go through the Zoning Commission. In regard to the nursing home, no formal application has been completed. Abandoned Homes – The homes on Bass Lake Road and Butternut Road have been demolished. The Commissioners are getting a lot of flack regarding demolishing the home on the Reiter property. Ed Hren had sent a letter to the Commissioners in support of going through with the demolition. When asked about the batting cages on Bass Lake Road, Mr. Kearns said the property owner has until the end of the month.

The meeting was adjourned at 9:12pm. The next scheduled meeting is December 13, 2010 at 7pm.
